## DIRECTIONS TO MASTERSON STATION PARK

**Directions to the site:** From I-75 southbound and I-64 eastbound exit at exit #115 Newtown Pike route 922 and turn right.

From I-75 northbound and I-64 westbound exit at exit # 115 Newtown Pike route 922 and turn left.

Follow Newtown Pike to just past the 6th traffic light and turn right onto New Circle Rd. (Rt. 4). Take New Circle Rd. to the second exit. Exit onto Leestown Pike US 421 and turn right. Go 2.5 miles on Leestown Pike to Ruffian Way, which is the park entrance on the right. Turn right into Masterson Station Park. At the first gravel road to your left, turn left. This gravel road is bordered by a high chain link fence to your right. The field is to your left over the crest of the hill. Please park along the road or under the tree line.

**ELIGIBILITY**

All entries shall be individually registered with the American Kennel Club, the Federation Cynologique Internationale, an ASFA recognized foreign or ASFA Board approved registry. If this is your borzoi's first ASFA trial, you must submit a copy of his registration paper, and the ASFA Certification Form. If your dog has earned the AKC senior courser, AKC field champion, LGRA GRC, NOTRA ORC, or Canadian field champion title, fill out the "Wavier" portion of the ASFA certification form, & include a copy of the dog's title. Otherwise, fill out the "Certification" portion, which has to be signed by a licensed ASFA judge who has watched your dog coursing with another dog.

Late, incomplete, conditional, unsigned, unpaid entries will NOT be accepted. Owners may not substitute for lame or in-season borzoi.

**Entries will not be acknowledged by mail.**

**STAKES OFFERED**

**Open Stake:** Any eligible Borzoi who has met certification requirements, excluding ASFA Field Champions of Record. A photocopy of the Borzoi's registration must be submitted at the Borzoi's first trial.

**Field Champion Stake:** Any ASFA Field Champion Borzoi.

**Veteran Stake:** Any eligible Borzoi whose age exceeds six years, who has met certification requirements. Points earned in this stake are towards the V-FCH or V-LCM titles.

**Additional Non-Regular Stakes**

**Kennel Stake:** Any two eligible Borzoi designated at the time of entry in one of the regular stakes and owned by the same individual.

**Breeder Stake:** Any two eligible Borzoi designated at the time of entry in one of the regular stakes and bred by the same individual.

**CONDITIONS OF ENTRY**

All entries must be at least one year of age on the day of the trial. Stakes will be split if entry in any one stake is 20 or more at the time of the draw. Bitches in season and lame Borzoi at Roll Call will be excused and entry fee refunded. Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered. Borzoi not present at the time of Roll Call will be scratched. Hound certification runs will not be offered. A battery operated, continuous loop lure machine, with backup equipment, will be used. Lure will consist of highly visible plastic strips. **A \$5.00 fine will be assessed for any hound loose on the field not competing in the course in progress.** All Borzoi run at the owner's sole risk. **Please be responsible Borzoi owners and clean up after your dogs and yourselves.**
