



## Borzoi Club of America National Juried Art Show

May 16–22, 2010  
Fort Mitchell, Kentucky

### Purpose

The Borzoi Club of America is pleased to offer artists the opportunity to exhibit work in a jurored show devoted exclusively to the Borzoi breed. All entries must include a Borzoi in the subject matter.

### Eligibility

The exhibition is open to artists 18 years of age or older. Works must be original and executed solely by the person in whose name they have been submitted. All entered artwork must be priced and for sale.

### Sales

All exhibited work will be available for sale. BCOA will retain a commission of 20% on all sales that occur during the exhibit or which occur later as a direct result of the exhibit. The balance will be mailed to the artist.

### Juror

David Humphreys is a nationally acclaimed commercial and fine art photographer in Baton Rouge, Louisiana. He has won numerous awards including the Photo District News / Nikon Award. His website is [www.fabphotos.com](http://www.fabphotos.com).

### Jurying Process

Selection for both exhibition and awards will be made from CDs. Accepted artists will be notified by postcard.

### Categories

- Oil or Acrylic Paintings
- Photography
- Watercolor Paintings
- Sculpture
- Drawing
- Pastels
- Hand Pulled Prints
- Other Media (*for mixed media and works that are not appropriate in any other category*)



### Awards

Best In Show \$100  
Best Performance \$50  
Best Personality \$50  
Most Humorous \$50  
Best Head Study \$50  
2 Awards of Merit \$50  
(Selected works may be published in the *Borzoi Connection* magazine and in the online gallery.)

### Entries

1. Each artist may enter up to three (3) works.
2. All entries must be submitted as digital files on CD in jpg format with a minimum image size of 1500 pixels and no larger than

3000 pixels. We suggest using RGB color profile and the highest quality option when saving.

3. Please do not add watermarks, signatures, or borders to images.
4. CDs must be labeled with name, address, and phone number. Use one standard CD for all entries. Burn the CD for playing on a Mac computer.
5. The CD must be accompanied by a completed entry form and full payment.
6. Artwork that differs from the entry image will be disqualified.
7. Entry CDs become the property of the show committee and will not be returned.
8. Email entries will not be accepted.

### Fees

There is a non-refundable fee of \$20 for entry of 1-3 pieces. Checks or money orders should be made payable to BCOA.

### Accepted Work

All works accepted must be "show ready" for presentation.

Two-dimensional pieces must be wired for hanging. We recommend that plexiglass be used on shipped works (instead of glass).

Maximum size accepted for two-dimensional work is 48" in any direction.

Three-dimensional works must not exceed 8' in height, cover more than

4 square feet of floor area, or weigh more than 50 lbs.

Works shipped by carrier must be adequately packed in crates or packages suitable for return. Artist must provide for cost of return shipping should the work not sell.

Accepted works cannot be substituted and are committed for the duration of the exhibit.

No artwork will be returned until after the exhibition date; and the artwork will only be returned to the original location and lender or his/her authorized agent.

Any artwork not conforming to the accepted images, not fulfilling the listed requirements, or not being adequately presented may be eliminated from the show.

### Use of Images

All entrants agree that any image submitted to the BCOA National Juried Art Show may be used for marketing and promotional purposes directly related to the show. This use may include, but is not limited to, publication in the *Borzoi Connection*, advertisements, electronic media, Internet, catalog, DVD, print, and web. Any image used by the BCOA National Juried Art Show shall carry a credit line of the artist. Copyright and all other rights remain that of the artist.

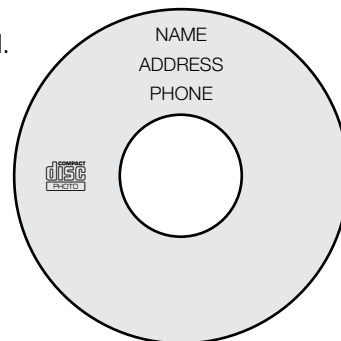
### Insurance

All art will be insured for declared value while on exhibit. Artists are responsible for insuring works during transit to and from the event.

- Week of 4/5/10 ..... Selections made by juror.
- Week of 4/12/10 ..... Notification of acceptance status by postcard or e-mail.
- Week of 4/19/10 ..... Accepted work available for preview online.
- Week of 4/2/10 ..... Press release distributed.
- 5/17/10 ..... Arrival deadline for accepted works.
- 5/21/10 ..... Reception, awards, and silent auction.
- 5/22/10 ..... Unsold work shipped back to artists.
