



## 2011 TRIATHLON

The Triathlon will consist of three evenly weighted events:

- Lure Coursing - April 3, 2011**
- Obedience Trial - April 5, 2011**
- Conformation - April 7, 2011**

The purpose of the Triathlon at the Borzoi National Specialty is to explore the natural intelligence and abilities of the breed and to display its versatility. The Triathlon event is a day-of-performance event. No previous titles or other criteria are necessary to enter nor will credit be given for such. All Borzoi entered in the Triathlon must also be entered in a regular or non-regular class at the regular entry fees for Conformation, Obedience and Lure Coursing.

This year we are offering an Altered Class that Triathlon participants may enter as a conformation class requirement.

### ALTERED CLASS

**Open to any dog or bitch who has been spayed or neutered. Winner of this class will not compete for Winners or Best of Breed. All other dog show rules shall apply.**
