Early acceptance of hounds for members of the field committee may begin one-half hour prior to published test hours.

**ELIGIBILITY**

All entries must be one year of age or older and individually registered with the American Kennel Club or an AKC recognized foreign registry, or have an ILP or PAL number from the AKC. Spayed and neutered hounds are eligible. Monorchid & cryptorchid dogs are NOT eligible. Bitches in-season and lame hounds will be excused and entry fees refunded. Owners may NOT substitute for lame or in-season borzoi. Borzoi not present at the time of roll call will be scratched. Entries will not be acknowledged by mail. Incomplete, unsigned, conditional, unpaid or late entries will not be accepted.

**TESTS OFFERED**

**JUNIOR COURSER (JC) TESTS:** Open to all hounds of an eligible breed at least 12 months of age. A hound running alone shall receive one qualification from a judge, and second Qualification from a different judge at a separate event, stating that the hound complete a six hundred (600) yard course with a minimum of four (4) turns. The hound must complete the course with enthusiasm and without interruption. Additional rules and regulations may be found on the AKC website - <http://www.akc.org/pdfs/rulebooks/RELURE.pdf>

**TRIAL STAKES OFFERED**

**OPEN:** Open to all eligible Borzoi that have attained an AKC QC Certificate or have previously run in Open. This requirement is waived for hounds that have earned a Field Championship title from the ASFA or the CKC. Hounds that have been disqualified from trials may not be entered. **Hounds that have an AKC Field Championship title are not eligible to enter the Open Stake.**

**OPEN VETERAN:** Open to all Borzoi eligible to enter Open or Special Stakes who are 6 years or older.

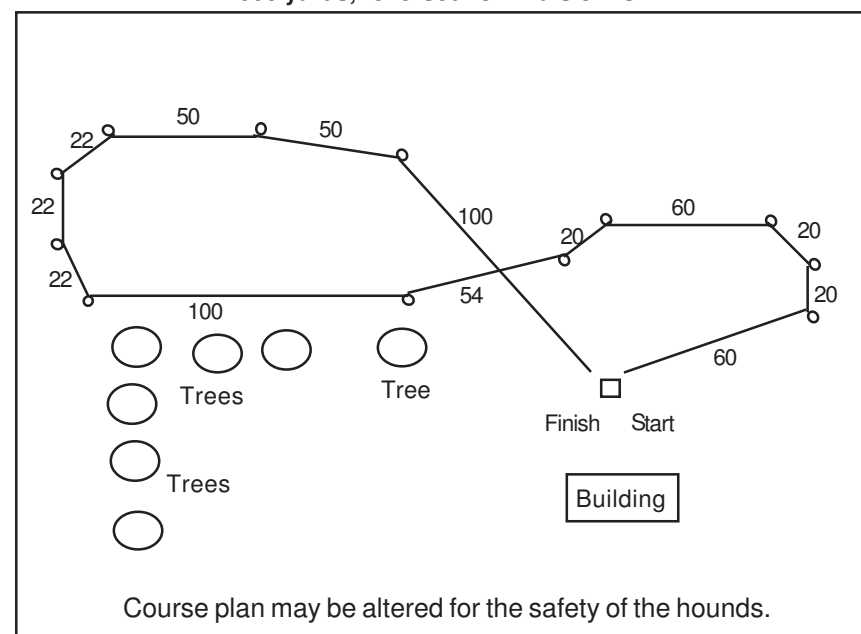
**SPECIAL:** Open to all Borzoi that have earned an AKC Field Champion Title. No championship points will be awarded from this stake. (LCX points will be awarded.)

**A \$5.00 fine will be assessed for any hound loose on the field not competing in the course in progress.** There will be a \$50 fine for those who do not pick up after their dogs.

A battery operated, continuous loop lure machine, with backup equipment, will be used. Lure will consist of highly visible plastic strips.

BCOA reserves the right to alter the course plan if required by weather and/or field conditions prior to or on the day of the trial, which may affect the usability of the field. Any person may, upon reasonable complaint, be asked to leave the grounds of the field trial by the Field Trial Committee, will forfeit entry fee(s), and may be disciplined by the AKC.
