## DIRECTIONS TO WATERFORD BEACH PARK

(Site is adjacent to the Eugene O'Neill Theater Center)

**From New York or New Haven:** RT 95 North to Exit 75 (Waterford 1-A). Follow approximately 3-4 miles, passing a cemetery and Waterford Post Office on right. Turn RIGHT at light onto Avery Lane (Silva's Package store on right just before the light.) At next light go STRAIGHT onto Great Neck Road which is also Route 213. Follow 3 miles to STOP sign. Turn RIGHT – continuing on Great Neck Road ¼ mile. At STOP sign turn RIGHT onto O'Neill grounds.

**From Crowne Plaza (Host Hotel), Boston or Providence:** RT 95 South to Exit 81 (Cross Road). Turn LEFT at bottom of short ramp – pass Walmart and shopping center on right. At light turn LEFT onto Cross Road. Follow to junction 1-A (bottom of hill). Turn LEFT onto Route 1-A. Approximately 2.5 miles turn RIGHT onto Avery Lane (Silva's Package store on right just before the light.) At next light go STRAIGHT onto Great Neck Road which is also Route 213. Follow 3 miles to STOP sign. Turn RIGHT – continuing on Great Neck Road ¼ mile. At STOP sign turn RIGHT onto O'Neill grounds.

**From Hartford and North:** Route 2 South to Route 11 from Hartford follow signs to New London – Route 11. At the end of Route 11 turn LEFT at bottom of ramp. At first light (Salem Four Corners) turn RIGHT onto Route 85 toward New London. After passing the Oakdell Motel on the left you will come onto a set of lights. Turn RIGHT at the lights onto Cross Road. Follow to junction with Route 1-A (bottom of hill). Turn LEFT onto Route 1-A. Approximately 2.5 miles turn RIGHT onto Avery Lane (Silva's Package store on right just before the light.) At next light go STRAIGHT onto Great Neck Road which is also Route 213. Follow 3 miles to STOP sign. Turn RIGHT – continuing on Great Neck Road ¼ mile. At STOP sign turn RIGHT onto O'Neill grounds.

**ELIGIBILITY**

Only purebred Borzoi may be entered. All entries shall be individually registered with the American Kennel Club, the Federation Cynologique, an ASFA- recognized foreign or ASFA Board approved registry. Spayed or neutered Borzoi may compete.

ENTRIES WILL NOT BE ACKNOWLEDGED BY MAIL

Incomplete, unsigned, conditional or late entries will not be accepted. Substitutions are allowed for lame or in-season hounds until time of Roll Call. An entry received for the Open or Veteran stake marked "First Time Entered" and not accompanied by a Hound Certification or a Waiver of Certification will be deemed incomplete.

**STAKES OFFERED**

**Open Stake:** Any eligible Borzoi who has met certification requirements, excluding ASFA Field Champions of Record. A photocopy of the Borzoi's registration must be submitted at the Borzoi's first trial.

**Field Champion Stake:** Any ASFA Field Champion Borzoi.

**Veteran Stake:** Any eligible Borzoi whose age exceeds six years, who has met certification requirements. Points earned in this stake are towards the V-FCH or V-LCM titles.

**Additional Non-Regular Stakes**

**Kennel Stake:** Any two eligible Borzoi designated at the time of entry in one of the regular stakes and owned by the same individual.

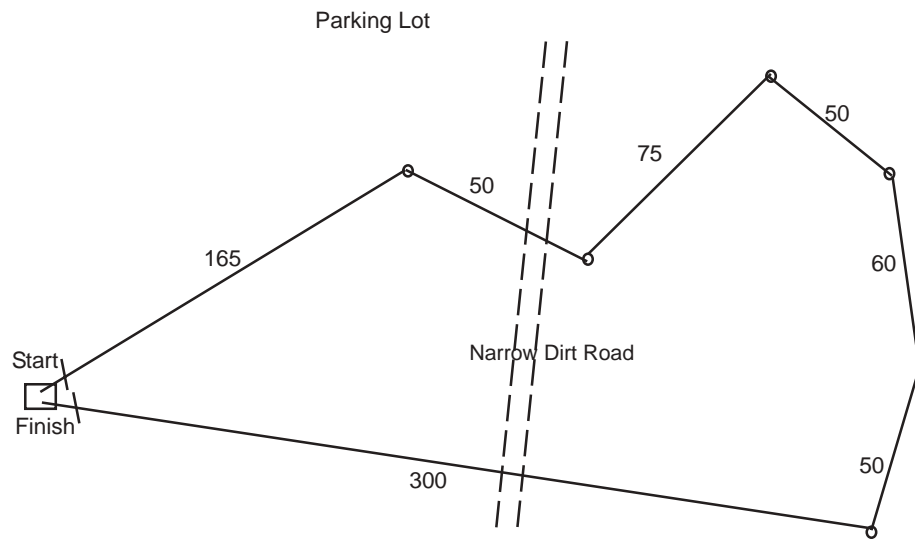
**Breeder Stake:** Any two eligible Borzoi designated at the time of entry in one of the regular stakes and bred by the same individual.

**CONDITIONS OF ENTRY**

**All entries must be at least one year of age on the day of the trial. Stakes will be split if entry in any one stake is 20 or more at the time of the draw. Bitches in season and lame Borzoi at Roll Call will be excused and entry fee refunded. Borzoi not present at the time of Roll Call will be scratched. Hound certification runs will not be offered. A battery operated, drag lure machine, with backup equipment, will be used. Lure will consist of highly visible plastic strips. A \$5.00 fine will be assessed for any hound loose on the field not competing in the course in progress. All Borzoi run at the owner's sole risk. Please be responsible Borzoi owners and clean up after your dogs and yourselves.**
