##### **AKC Delegate's Report – Barbara O'Neill**

I was seated to the AKC Delegate body on June 9 with a glowing introduction by Karen Mays. Thank you, Karen. Although the meeting was short, 2 ½ hrs, discussion was interesting. There is a major concern in that AKC registration of purebred dogs has been continually decreasing. The AKC relies on fees from litter and dogs registrations to fund programs and to remain the leading advocate for purebred dogs. Too often, new owners forget to register their puppies. Currently fewer than half the puppies from AKC litters become registered. The AKC has implemented an AKC Registration Pledge Challenge to all clubs. The role of BCOA would be to encourage our members to sign a pledge on the AKC website [www.akc.org/regpledge](http://www.akc.org/regpledge). The goal is for breeders to have 100% of their puppies registered with the AKC.
