- 3. KC Artley moved, seconded by Kelly Brunarski, to accept the pending chairs for Challenge Trophies and Obedience. Motion Carried.

Statisticians

1.Clarified duties regarding reporting to the Aristocrat, sending certificates and medallions: add to description of the Standing Committees Responsibilities statisticians for AKC/ASFA lure coursing, LGRA, NOTRA, and Obedience/rally/agility/tracking are responsible for mailing the title medallions to members for the first title that dog earns in that field.

2. We received a request from a member that only those dogs earning at least 3 qualifying scores in a calendar year be listed in the Top 10 rankings for Obedience & Rally. Dogs earning only 1 or 2 qualifying scores in a calendar year would no longer be listed. The Board felt that this standing rule change should not be decided at this meeting because more data and members' feedback are needed. Since we have a deadline now for the 2011 awards, the Board decided that the obedience/rally statistician be advised to use the current standing rule, that any and all scores count, for the 2011 Top 10 rankings in obedience & rally.

Nominating Committee: Table appointing 2012 committee until May. Security of Member Information

RMBC expressed concern over security of members' information sent by Clubs to Corresponding Secretary to approve specialties. This information is not shared by BCOA but it is used as a point of reference when questions of BCOA membership arise during regional clubs' application for specialties and questions regarding specific borzoi owners who are not BCOA members. However, she noted, AKC *does* share information.

Best in Futurity Sculpture

The photos of the clay sketch sent by sculptor Garry Newton were not satisfactory because the dog does not look like a puppy. Joyce Katona will contact him. Send Joyce any recommendations of potential artists.

Junior Handler
