# **Standing Committee Reports**

# Annual Versatility Award: Karen Ackerman

Thank you for your comments and suggestions regarding the revisions for the AVA. In reviewing the recommended changes, I do have some concerns regarding the obedience section.

First, it would be the only area where the statement: the maximum number a non-champion may receive is, will be removed. By deleting this, the award will not be consistent with all of the other sections of competition. Conformation, coursing, racing, and agility, all have a statement which limits the number of points a borzoi may earn in one year, should the dog not complete the title requirements for that category.

Secondly, it allows the hound which does not complete its title in one year to obtain points equal to a borzoi who earns its title. For example, a borzoi competing for its CD can earn two legs (2x10 = 20); and if that dog get two high in trials at those events (2x5=10), the dog will have thirty points. That would be the same total a dog who completed its CD in one year would have, should that hound not have received any high in trials. In addition, this scenario could apply to the CDX and the UD.

Third, it sets up the potential for having a borzoi obtain more points in one year than one who completes its title requirements in that section. For example, in the UDX category, a borzoi could possibly earn nine of its legs (4x9 = 36). If the hound earns one high in trial for an additional five points, the total available would be 41. One point more than a dog that completes its UDX title for 40 points.

These are a few of my concerns. There should be a statement at each level of competition in the obedience section that limits the number of points for a title not completed.

#### Aristocrat Committee: Helen W. Lee

I've just realized that another Aristocrat deadline is approaching and I don't know whether I can accept ads for it or not. If I \*can\* accept ads, what would the rates be? I need some guidelines to be set down by the Board, please, as I've received an enquiry about advertising. Years ago the Aristocrat accepted ads, both individualized ones and then toward the back of the publication a section of New Title Winners which were formatted all the same and for a lower rate.

Also, I need to point out that I am not prepared to be the Aristocrat editor if it is going to go back to print publication. It is a LOT more work to prepare files for print production and I really don't want to have to go that route any more. I don't think that there will be enough ad revenue to support such an undertaking either.

#### Judges Education Coordinator Patti Widick Neale

2013 will be a full year for Judges Educational events. For better or for worse ALL three national judges associations are requesting Borzoi presentations at their Group events this year. That means that student Borzoi judges need to get their acts in gear this year, for 2014 will be much more spare.

On March 14' in Louisville, Kentucky, Borzoi will be presented in a seminar format as part of the American Canine Education Foundation Hound Institute, the educational arm of Senior Conformation Judges Association. The foundation holds seminars for an entire Group in Louisville every year in an event known as informally known as Wally Week after founder, Colonel Wallace Pede. I am planning on the usual format of Friday night seminar and workshop, Friday and Saturday ringside mentoring at the National Specialty in Lancaster, PA. The dates will be May 17 and 18.

In July, DJAA, Dog Judges Association of America will hold Hound Group workshops in Houston, in conjunction with the Reliant World Series of dog shows. The actual date for the Borzoi presentation is not firm, but it will be between July 18 and 21. In August, ADSJ, American Dog Show Judges Association will feature sighthounds, as it does every other year in a collegial setting at Indiana University of Pennsylvania, in Indiana, Pennsylvania. Dates are August 18 through 23. Borzoi have always been well-represented there, thanks to the efforts of numerous breeders and exhibitors in the Northeast and eastern Mid-West. # **HEALTH COMMITTEE:** Ginger Jones

#### **BORZOI HEALTH SURVEY AND TEST STATISTICS:**

The total number of respondents in our OFA Borzoi health survey is now 928 participants, 8 dogs more than in my November of 2012 report.

- There are now 690 dogs listed in the open OFA DNA test database for Degenerative Myelopathy up from 604 dogs listed in my November of 2012 report. 29% of the total dogs are indicated as other than normal (6 at risk, 134 carriers).
- There are now 1194 dogs in the open OFA heart database up from my November of 2012 report of 1047.
- 4% of the total dogs are indicated as other than normal (6 abnormal, 12 equivocal).
- There are 874 dogs in the open OFA thyroid database up from 728 in my November of 2012 report.
- 24% of the total dogs are indicated as other than normal (19 abnormal, 51 equivocal).
- I received the 4th quarter of 2012 CHIC and OFA reports.

#### **CANINE HEALTH FOUNDATION & MORRIS ANIMAL FOUNDATION GRANT RESEARCH:**

Morris Animal Foundation -

I received their annual grants request report and reviewed the research grants for canines.

There are two heart research grants of interest:

!. Developing a New Technique to Study Canine Heart Disease – Dr. Carla M. Lacerda, Colorado State University This grant requests to study Myxomataous mitral valve disease (MMVD) as one of the most prevalent heart diseases and the most common cause of heart failure. The research tests whether strain on the mitral valves causes proteins and other factors to kickstart MMVD. Data collected from this study could yield new insights into the development of MMVD, validate a new model to study the disease process and identify new therapeutic strategies.

2. Identifying Genetic Markers for a Congenital Heart Disorder in Newfoundlands – Dr. Kathryn M. Meurs, North Carolina State University

This study looks for a causative genetic mutation for subvalvular aortic stenosis in Newfoundlands. Identification of a causative mutation or marker will help researchers develop a genetic screening test to reduce disease prevalence in Newfoudlands and other at-risk breeds.

At this point, it would be my preference to support two research grants from the CHF instead of these from the Morris Animal Foundation the reason being that heart research conducted by the CHF can be paid for from our Borzoi Donor Advised Fund while grants request from Morris Animal Foundation must come from our general BCOA Health Fund and there are other items of greater urgency that require these funds as expressed later in my report.

From the list of 2013 approved Oak Research Grants from the CHF (attachment included for research details), there are two grants I would like the board to consider funding at \$2500 each from our CHF Borzoi Donor Advised Fund. They were included in my November board report as information and are as follows:

#### 01753: Identification of Genetic Factors That Alter the Severity of Cardiomyopathy

Principal Investigator: Dr. Kathryn M Meurs, DVM PhD

#### 01760: Use of Gene Therapy to Treat Dilated Cardiomyopathy

Research Program Area: Cardiology

Principal Investigator: Dr. Margaret M. Sleeper, VMD, University of Pennsylvania

With the volatility of the current economic market that our Donor Advise Fund is invested in, it would make good sense to take advantage of utilizing these funds for current heart research support. We just recently deposited an additional \$2000 into the fund as the results of the calendar project fundraiser conducted through the efforts of Renee McCartin, Nancy Hopkins and the Potomac Valley Borzoi Club. I urge the board to approve the funding request for these two research grants. Through the assistance of Dr. Sleeper I was able to obtain two cardiologists and a seminar speaker for our PA Nationals. She has been extremely support of our clubs health initiatives.

In addition, the CHF has launched a "Bloat Initiative RFP". (Request for proposal) This initiative is a plea to all clubs, organizations and individuals to support with advanced funding while the CHF petitions the research community for proposals for a more thorough investigation of the causes and prevention of bloat. Little is still know about this ailment and there has been a unanimous plea for help from many breed clubs. The CHF wants to really drive some results towards this initiative. At this point in time, I would request that the board approve a donation for the Bloat Initiative RFP in the amount of \$3000 to come from our health committee funds. It will take some time for the research community to put together their research grant proposals and for the review and approval process through the CHF. I would not expect to see these as approved active grants until next year's grant cycle at the earliest. At that time, we can review these specific grants and determine which ones we would like to support with additional funding. This year's National initiative for health donations will be put towards the Bloat Initiative RFP. There is a group of members working on coordinating fundraising through the silent and art auctions with items donated for the 50/50 with 50% going to the Bloat Initiative RFP. In addition, we will be taking any cash donations to the health committee and directing them to this initiative as well. I believe we will receive a strong financial support from our borzoi community.

#### **ADDITIONAL CHF INFO:**

The Purina Parent Club Conference will be held this August  $9^{th} - 11^{th}$  in St. Louis. The registration for participants is \$250 and I'm requesting board approval for funding for the registration fee. If there are additional openings for the conference, we may be able to have an additional representative from the BCOA attend. If there is an opportunity for an additional BCOA member to attend the conference I am requesting the approval for Leonore Abordo to attend with me to become more familiar with the CHF objectives, what they have to offer parent clubs and to make contact with key people involved with the research community and the CHF. Leo has been extremely active in the health committee and this opportunity would prove to be significantly beneficial for the club as well as the health committee. The fee for additional attendees is \$500 if there is an opening and I'm more than willing to split this cost with Leo and share a room with her in order to keep the cost in check for both of us.

I received the annual request in December from the CHF for our breeds top health concerns and after reviewing our survey and test result statistics, the order has remained the same:

Oncology\Osteosarcoma

Neurology\Degenerative Myelopathy

Endocrinology\Hypothyroidism

Gastrointestinal\Gastric Dilatation-Volvulus Gastrointestinal\Pancreatitis Cardiology\Dilated Cardiomyopathy Cardiology\Tricuspid Valve Dysplasia Respiratory\Chylothorax Cardiology

So these are what will continue to remain on the CHF records for the borzoi breed top health concerns for calendar year 2013.

#### **2013 NATIONALS CLINICS AND SEMINAR:**

I've contracted for two cardiologists for our heart clinic. Dr. James Buchanan – fee \$25 per dog for auscultation and \$25 for single lead EKG if follow up is indicated and owner is interested. Echocardiograms – Dr. Ellen Davison – fee is \$200 per dog with a minimum guarantee of 5 dogs. Seminar speaker is Dr. Margret Casal - reproductive specialist who will speak about infertility issues in males and females, smaller litter sizes and loss of neonatal pups. Speaker fee is \$200. Contracts have been sent to each.

I've contacted Michigan State University thyroid lab to request a discounted lab fee rate for our thyroid clinic. I received a phone call from the labs coordinator confirming that they would be able to provide us with a rate of \$50 per sample fee. I will be placing an order shortly for supplies for the thyroid clinic. Approximate costs are \$100 for needles, syringes, blood tubes, alcohol, sharpie container, labels, and packaging materials for shipping. We already have a portable centrifuge. Karla Smith, DVM has contacted the PA state licensing board to determine if she needed to file for a license to practice in PA in order to be the veterinarian in attendance to sign the thyroid forms. PA indicated that for a one day clinic event, a PA license to practice was not required. Her current state license was sufficient.

I still need to confirm with Eddie Dzuik, OFA that they will be able to provide us with the kennel discount rate for the OFA fee for the heart and thyroid submissions, but I'm confident they will support our cause. In addition, I will be asking him to publish our heart clinic as open to all breeds of dogs and list it on their calendar of upcoming clinic events. The thyroid clinic will only be available to borzoi.

I received more interest in the Purina FortiFlora product trial from our membership and sent an inquiry to the Purina representative, Arleigh Reynolds, but have not yet received a response back if they are still willing to conduct this trial with us. I'll follow up with Arleigh again over the next month as, in order to conduct the trial, participants would need to be actively on the product daily for at least a month prior to the Nationals event in order to receive any potential benefit from it. The intent is to determine if the product has a beneficial effect for controlling stress diarrhea, especially in puppies, during a week-long stressful event such as the National Specialty. I had good success with it personally and felt our members might receive a benefit as well. I met Arleigh at the last CHF parent club conference two years ago when he provided a seminar on the product and discussed this opportunity with him at that time. Since they had not conducted a trial of this type before with this product, he was interested in the potential.

#### **MISCELANEOUS**:

I've created a Facebook page entitled "BCOA Health" and have loaded information about the national seminar and clinics and posted the Facebook info to the BCOAMembersOnly@yahoogroups.com group. It's a bit thread bare until I get a better grasp on the Facebook tools, but I hope to start a regular blog to keep BCOA members informed of information as I receive it from various organizations involved with canine health. I will continue to post info to the BCOA yahoo group.

AKC LCX and ASFA LCM titles (earned by the same dog) 2 point bonus

Open Field CC & CM or equivalent (same dog) 2 point bonus

GRC and ORC titles 5 points (currently 4)

The committee seeks input from the membership on these proposed point additions and changes, as well as the addition of new titles, such as AKC Tracking Titles, and AKC Companion titles (CGC, Beginner Novice, and other non-regular or optional classes). Also, obedience and agility titles from other established organizations could be recognized at half the point awards for AKC titles.

#### Dogs in Rescue

All Borzoi placed through BR-NC Adoption are spayed/neutered, microchipped, heartworm/lyme tested, and current on all vet care before placement. Adoption Applications are required, references are checked, and home inspection visits are done.

**Shanti 2012** — Shanti was given up to a Seattle veterinarian who neutered him then surrendered the dog to us. Shanti is three-four years old. He is other-dog aggressive though very, very sweet and cooperative with people. Shanti has been fully vetted and is available for adoption. Shanti remains in foster care while we search for an appropriate home for him.

**Moose 2012** – Moose was given up following a divorce. He had been much loved and well cared for throughout his life. Moose was placed in November in a Borzoi-experienced home where he has slowly and steadily settled in and bonded with his new owner.

**Cara Mia 2012** — Cara Mia, at two, was given up by her owner. After being spayed and brought up to date on vet care, she was placed in December with one of our tried and true rescue owners. Cara Mia has a Borzoi brother of her age and an older Borzoi sister, and made a very happy transition to her new life.

#### Dogs in BR-NC's Referral Program

BR-NC's Referral Program gives owners/breeders access to excellent homes while they retain full control over all aspects of placing their dogs. In return, BR-NC receives a \$100 donation to help cover the expenses of the dogs we take into rescue.

**Maya 2012** — 3-year-old Maya was placed in our Referral Program in late September by her breeder/owner, who wanted to find her a solid and loving pet home. She will be going to her new and Borzoi-experienced home after the holidays.

#### NBRF: Liz Duncan

The National Borzoi Rescue Foundation (NBRF) is dedicated to the rescue and permanent placement of all displaced borzoi across the United States. All borzoi are spayed/neutered and fully vetted prior to placement. Adoption applications, references checked and home visits are required prior to placement with emphasis placed on the quality of life, and special needs, of each individual borzoi.

2012 ended with 47 borzoi coming into NBRF. Of those, 4 were still looking for their forever home as 2013 began. To date for 2013, 4 additional borzoi have come into rescue and two have been placed in homes; 6 borzoi remain in foster homes and are available for adoption.

NBRF's Valentine's Day EBay Fundraiser is winding down at the writing of this report and to date, after ebay and paypal fees, \$1,488.23 has been raised by gracious donors, bidders, and our EBay volunteer who has done all the listings for us.

We are still awaiting the veterinary bill for our senior rescue in Arizona who came through surgery yesterday with flying colors after having 4 mammary tumors removed and a large fibrous tumor removed from the inside of her mouth. Prior to surgery it was confirmed that her lungs were clear of any growths or tumors so we, and the veterinarian, have great expectations for a comfortable quality life for this old gal. We are hoping that the Valentine's Day Fundraiser will cover her veterinary expenses.

NBRF encourages ALL breeders to permanently identify their borzoi and puppies with mirco-chips or tattoos. Without such identification, we are unable to contact YOU if your dog should ever end up in rescue.
