She will further inquire as to the level of interest in such an event and If members are interested, Rebecca will ask for volunteers to work on the project.

Your name will be published in the Board meeting minutes. If no letters are received protesting your application, you will be approved as a member at the following Board meeting. Your privileges as a member, including counting the wins of your dogs for top awards, start on the date you are approved as a member." Motion to approve made by KC Artley & seconded by Barbara O'Neill. All in favor. Motion passed.

Amendment to motion by Joy Windle, seconded by KC Artley: Additionally, Shift Member Code of Ethics currently on page one of member application to a separate page for applicants to keep for their reference. All in favor. Motion passed.

<u>Meet the Breeds</u>: Ron Williams will chair the BCOA booth at the "Meet The Breeds" September 28 & 29, 2013 at the Javits Center in New York City. Ron will need help with this, and is looking for volunteers who can bring borzoi for the public to see. Chris Neale will chair the BCOA booth for the "Meet the Breeds" at the December 2013 Eukanuba show in Orlando. In 2012 the BCOA booth won first in the Hound group booth competition, and Chris is hoping to do even better in 2013.
