Since our last BCOA Board meeting, I have contacted the membership of Region 5 numerous times on a variety of topics:

Results of the Coronavirus Opinion Poll, 2020 National Specialty Cancellation Memo, information
on the 2020 Nominating Process and Nominating Committee Names, President Williams's memo
explaining the situation to members on moving the 2020 judging slate to another date in the
future, the note regarding the vote for this, plus reminders to do so in a timely manner, as well
as, the results of the tally to accomplish this. Lastly, an email was sent regarding the advertising
rates for the memorial ads and new title holder ads plus the August deadline date. I forwarded

- the PVBC flyer to Region 5 advertising the two specialties in one day followed by one day of LGRA for the weekend of November 7/8, 2020.
- Lure Coursing information was shared with Region 5 members regarding the cancellation of the 2020 AKC National Lure Coursing Championship. Sandra Moore's email with the ASFA Communique attachment was forwarded to all which discussed Safe Practices and a discussion of a new event, Team Coursing. AKC Best Practices for Lure Coursing, Fast CAT and CAT were sent on.
- Information regarding the AKC titling requirements for obedience, rally and agility which were temporarily amended were sent on, as well as, the expansion of the AKC virtual program to rally intermediate class. Suggested Best Practices for obedience and rally were forwarded, too.
- Other AKC correspondence which was posted include several issues of their electronic weekly
 magazine, information for their educational webinar on the judging approval process which dealt
 with rules and policies, updates on their various programs, and club bylaw provisions for holding
 electronic meetings. In addition, their take on how to have a successful dog show during the
 current health crisis, the Learning Cluster, was emailed.
- Health updates, many of which were forwards from Nancy Hopkins via for membersonly list, included the following: raw meat recalls for Texas and Canada plus an email on pet loss support. A post to introduce Dr. Carpenter, Director of the AKC Canine Health Foundation was sent on. The USDA APHIS updates on the resumption of inspections during the pandemic from the AKC were mailed to all, as were posts on how to deal with pet stress caused by the Fourth of July. Revisions to USDA APHIS animal welfare act regulations were sent per the AKC announcement. The acknowledgement of May as Pet Cancer Awareness Month was forwarded. Links for the webinar on biomarkers for canine chronic kidney disease and the Harvard study on neuroanatomical argument supporting purposefully bred dogs was shared with Region 5.
- Legislative updates from Lyn Hoflin were posted for the following: Chicago, Illinois, Utah,
 Michigan, Iowa, South Carolina, Colorado, Vermont, and Nationwide. USDA National APHIS
 updates for licensing requirements was emailed. The HR6921 bill which was recently introduced
 for the importation of healthy dogs was shared with Region 5 members.
