Two different sites are being considered with the concern that temperatures in the area during May could be too warm to run lure coursing. Accordingly, April is being considered as an alternative. Locations need to be booked early in order to get the dates we prefer. B. Tolley has a good start and a group of volunteers lined up to be committee chairpersons. A proposal is anticipated in the near future.

This test measures things that are not part of the original purpose of the borzoi breed. There was a question if this would lead to an additional title. P. Hlatky will send the link to K. Novotny for B. Simpson explaining the AKCs position regarding the original purpose of the borzoi. The group asking for this stated they would be willing to make presentation to the board. It was agreed that would be a good thing to determine what they are hoping to accomplish with this test and get our questions answered. K. Novotny will ask B. Simpson to give her documentation explaining what their goals are and let us know when they would be able to make a presentation to us.

K. Novotny will tell K. Henderson to contact B.Danieli each year to make sure she is still on the puppy referral list.

B. Ewing would like to see CHIC numbers be published on the website. There was discussion as to the purpose of this request. K. Novotny will ask B. Ewing if she is volunteering to collect the stats for the CHIC numbers.

B. Ewing asked if the membership would want to switch from having a novice class to having an amateur owner class instead at the National. Discussion ensued. This will be placed on the agenda for the annual membership meeting at the National. K. Novotny will put together information as to how you qualify for each of these two classes so people understand the difference between the novice class and the amateur owner class.

We really do need to have an ASFA trial at the next Borzoi National as in pre-Covid19 times the club would lose its license to have ASFA trials after two years without an ASFA trial. R. Williams will contact K. Cassella about offering ASFA at the TX National. Can it be an ASFA TSE? Shirley found in the ASFA rules a statement that says Parent clubs are exempt from the 2-year rule. The local group putting on the National will decide. L. Hoflin suggested to send a copy of that rule to S. Moore.
