# 6. <u>REPORT OF THE AKC DELEGATE – Prudence Hlatky (see Supporting</u> <u>Document for report)</u>

P. Hlatky reported there will be 6 items going up for a vote at the next delegates meeting. Three relate to the AKC Charter and Bylaws and three are related to rules applying to dog shows. The board had already voted to instruct P. Hlatky to vote in favor of breaking the Bred-By classes into two different classes; 6-12 months and adult bred by exhibitor.

Discussion followed regarding whether or not the BCOA wants to participate in the AKC Preservation Sperm bank. If so, do we want to be involved at the development stage to determine the criteria for choosing stud dogs? Does BCOA want certain criteria when choosing dogs such as health tests, proven performance dogs, proven champions, champion puppies?

The AKC wants to work with only one individual from each parent club. At this time there are no charges for clubs to participate.

Since this topic is very complex it was suggested to wait until the regional governors have asked for input from their regions to see if the membership is interested in this program. P. Hlatky's report can be cut and pasted by the regional governors and used in a note to their regions.

The AKC will be implementing this program, the question is, does BCOA want to be a part of it?

It was suggested to send a blast email asking for interest from the membership and seeking volunteers.

**R.** Williams and **P.** Hlatky will work on a presentation to the membership and will let the board know before sending it out.

- National Health Clinic Report Leo Abordo Thank you to the army of dedicated volunteers that staffed our FOUR clinics over two days in Ohio. It was a stupendous undertaking and nearly 300 exams were conducted.

2022 / Texas: We are pleased to again offer two days of echocardiograms at our health clinics. The keynote speaker will provide updates on cardiac research projects currently underway at Texas A&M.

2023 / TBA: Preparations are underway and will be finalized as soon as a date and location are confirmed. Due to the increasing challenges in securing board-certified specialists at discounted rates, we are discussing long-term options. Concerns include travel expenses and state licensing requirements.

➤ Report on the AKC New Titles File - KC Artley

There is no committee for this, but since we have several new board members, I would like to explain what this file is used for. The AKC will only send the file to one BCOA member. It is sent once a month, electronically, as a csv file. It lists all AKC titles earned by borzoi in the previous month; an average of 60 titles per month. Here is an example of what one dog's new title looks like on the file:

She needs just the dogs' names with the BCOA members names and addresses, for specific AKC performance/companion titles as described in the BCOA Standing Rules "AWD 20 Title Medals".)

3. The Aristocrat. (Data is formatted for print and sent to Helen Lee as a rtf file.)4. Archives (All information from the files are kept both in the original format and in a database)

5. ROM (The archives database is used to validate titles, and also to assist BCOA members researching what titles were earned by the offspring of their sires/ dams.)
