The Board discussed the following motions made during the 11.5.22 F2F meeting at length:

- (1) Motion made to have Board approval for all future mandated health testing as recommended by the BCOA Health Committee, including those tests required for a CHIC number A. Sorbie Motion Seconded B. Tolley All in favor; none opposed Motion carried
- (2) Motion made to change required advanced cardiac exam (echocardiogram) for CHIC number recommended on the OFA Database site (until the BCOA membership can vote on this topic at the 2023 BCOA Annual Meeting) A. Sorbie Motion Seconded K. Horn Janek All in favor; none opposed Motion carried
- (3) Motion made to reinstate the auscultation requirement for the CHIC number (as required in prior years) A, Sorbie Motion Seconded K. Horn Janek All in favor; none opposed Motion carried

Motion made to rescind Motion #2 due to the Board recognizing not all membership is represented at an Annual meeting and wanting all membership the opportunity to voice their opinion via a membership survey – A. Sorbie
