- 4. The BCNC and the Turquoise Trail BC specialties will no longer conflict with one another.
- 5. Email from Barbara Binder: I recently received the Quick Reference Guide for Judges sent to all Borzoi judges from the Borzoi Club of America. As a breeder and a judge I find two very disturbing statements in this folder which should be defined and corrected.

1st The term "plush" has never been used in any Borzoi standard that I know of. As such the term should not have been added as a separate coat style without a change in the breed standard. Feathering on the legs and tail and a profuse rough around the neck is a part of the standard and applies to all coat styles. The current standard already emphases the importance of sound running gear over all.

2nd The devaluation of a correct mouth is a huge problem. Teeth and bite are very important in the hunting dog. It is <u>part of the structure and type</u> of the Borzoi. Teeth faults should be judged on the degree to which they affect the performance of the hunting dog. Emphasis should be placed on the strength of the jaws and teeth but that's a different discussion entirely.

REGION 5 – Kristina Terra

The Region 5 hosted the BCOA Board meeting at the proposed 2024 BCOA National specialty hotel in Olympia, Washington. The hotel's Sales and Marketing Manager gave a tour of the facilities to the members of the board.

In the months before and after the board meeting, a few additional changes to the hotel contract have been added and accepted by the manager, as requested by the Show cochairs. The contract has been passed on to the Board and the BCOA attorneys for final negotiations and signing. The attorneys have found several additional questions to be settled. Everyone who will be working on the 2024 BCOA National is eager to hear back and start the real work. Hillary Tregillis, who had negotiated the initial contract and has conducted a large dog event at the same venue, is the Facilities Coordinator. At the Puyallup, WA shows, the 2024 BCOA National preparation work, committees and needs were discussed with the members of the Puget Sound Borzoi Club.

In January, I was notified by a local Borzoi person about the viral Borzoi meme going around on social media. The #borzoi hashtag had gone from 300 million to nearly a billion in days. I passed on this information to the board. This type of hype may result in a raising popularity of the breed and so the breeders should make sure that due diligence is done with prospective homes.

I have contacted all members that needed to pay their dues and life-members that needed to update or confirm their information. I had received several replies and also offers to help at the 2024 National in Olympia. Thank you to the region 5 members for being so generous with your time!
