Early acceptance of hounds for members of the field committee may begin one-half hour prior to published test hours.

**ELIGIBILITY**

All entries must be one year of age or older and individually registered with the American Kennel Club or an AKC recognized foreign registry, or have an ILP or PAL number from the AKC. Spayed and neutered hounds are eligible. Monorchid & cryptorchid dogs are NOT eligible. Bitches in-season and lame hounds will be excused and entry fees refunded. Owners may NOT substitute for lame or in-season borzoi. Borzoi not present at the time of roll call will be scratched. Entries will not be acknowledged by mail. Incomplete, unsigned, conditional, unpaid or late entries will not be accepted.

**TRIAL STAKES OFFERED**

**OPEN:** Open to all hounds that have obtained an AKC Qualified Courser (QC) certificate. The AKC QC certificate must be submitted if this is a first time entry. An ASFA Certification Course certificate may be submitted in lieu of the AKC Qualified Course certificate. This requirement will be waived for hounds that have earned a Field Championship title from the American Sighthound Field Association (ASFA) or the Canadian Kennel Club (CKC). ASFA or CKC Field Champions must submit a copy of their title certificate to the host club when they enter their first AKC Open Stake. This copy must be included when the results of the trial are sent to the AKC. Championship points earned from the Open Stake will only count toward a Field Champion title.

**OPEN VETERAN:** Open to all Borzoi eligible to enter Open or Special Stakes who are 6 years or older.

**SPECIAL:** Open to all Borzoi that have earned an AKC Field Champion Title. No championship points will be awarded from this stake. (LCX points will be awarded.)

**A \$5.00 fine will be assessed for any hound loose on the field not competing in the course in progress.** There will be a \$50 fine for those who do not pick up after their dogs.

A battery operated, continuous loop lure machine, with backup equipment, will be used. Lure will consist of highly visible plastic strips.

BCOA reserves the right to alter the course plan if required by weather and/or field conditions prior to or on the day of the trial, which may affect the usability of the field. Any person may, upon reasonable complaint, be asked to leave the grounds of the field trial by the Field Trial Committee, will forfeit entry fee(s), and may be disciplined by the AKC.
