#### ELIGIBILITY

All entries must be one year of age or older and individually registered with the American Kennel Club or an AKC recognized foreign registry, or have an ILP or PAL number from the AKC. Spayed and neutered Borzoi are eligible. Monorchid & cryptorchid dogs are NOT eligible. Owners may substitute a borzoi which they own for a lame or in-season borzoi. Borzoi not present at the time of roll call will be scratched. Entries will not be acknowledged by mail. Incomplete, unsigned, conditional, unpaid or late entries will not be accepted.

**TRIAL STAKES OFFERED**

**JUNIOR COURSER (JC) & QUALIFIED COURSER (QC) TESTS:** Open to all Borzoi at least 12 months of age. A Borzoi running alone shall receive one qualification from a judge, and second qualification from a different judge at a separate event, stating that the Borzoi complete a six hundred (600) yard course with a minimum of four (4) turns. The Borzoi must complete the course with enthusiasm and without interruption. **Qualified Coursers** Borzoi will run with another Borzoi (Testing Borzoi). This certification is required to enter a Borzoi in an Open Stake. The handler presenting the qualifying Borzoi shall be responsible for providing the Testing Borzoi for the qualifying course. Additional rules and regulations may be found on the AKC website.

**OPEN:** Open only to Borzoi that hold an AKC QC certificate OR have run in the Open Stake prior to Jan. 1, 2010, OR have a Senior Coursers title, OR have an ASFA or CKC field champion title (a copy of this title must be attached to the entry form if the QC requirement is to be waived). Championship points are awarded from this stake. Borzoi under disqualification from AKC, ASFA, or CKC Field Trials may NOT be entered.

**OPEN VETERAN:** Open only to Borzoi that are eligible to enter either Open or Specials Stake, and are of Veteran age as determined by their Parent Breed Club. Championship or LCX points may be awarded from this stake. Borzoi under disqualification from AKC, ASFA, or CKC Field Trials may NOT be entered.

**SPECIALS:** Open only to Borzoi that are eligible to enter the Open Stake and have earned their AKC Field Championship title. LCX points may be awarded from this stake. Borzoi under disqualification from AKC, ASFA or CKC Field Trials may NOT be entered.

**SINGLE:** Open to all Borzoi of eligible breed, including those that are otherwise disqualified from entering the regular stakes (open, specials and veteran). Borzoi entering in the singles stake may not also enter a regular stake at the same event. No championship or LCX points are awarded from this stake.

No award will be mailed.*

Any person may, upon reasonable complaint, be asked to leave the grounds of the field trial by the Field Trial Committee, will forfeit entry fee(s), and may be disciplined by the AKC. A \$5.00 fine will be assessed for any Borzoi loose on the field not competing in the course in progress. There will be a \$50 fine for those who do not pick up after their dogs.

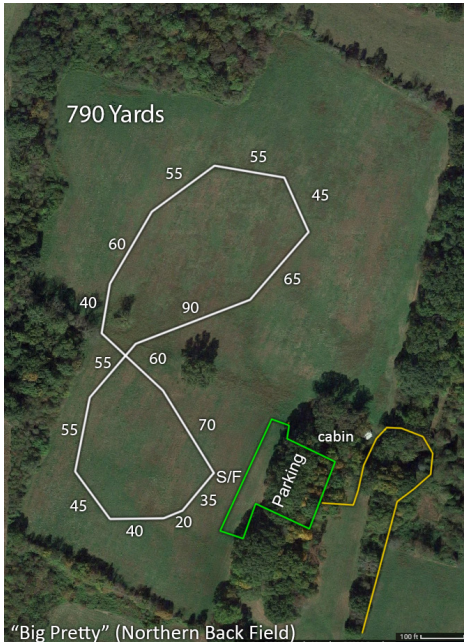

## COURSE PLAN

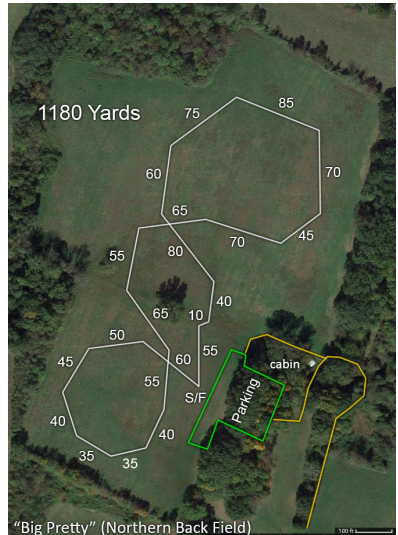
790 yards, reversed for finals & BOB

A battery operated, continuous loop lure machine, with backup equipment, will be used. Lure will consist of highly visible plastic strips.

## DIRECTIONS

Travel time is approx. 30 minutes from the host hotel.

GPS/MAP: "99 Glendale Rd., Limestone TN 37681"

Google Maps works well. Verizon has the best cell coverage, but reception on the field may be spotty. There will be signage for the "field entrance."

**FROM I-81 (N, E, W) (12 MINS):** NEVER USE EXIT 44. Take exit 50 for TN-93 south for 1.8 miles. Continue straight onto TN-81 for 2.2 miles. Right on Cherry Hill Rd for .6 miles. Bear left to Martin Rd. for .9 miles. Right on Glendale for 2.7 miles.

**FROM I-26 (S) (40 MINS):** Take exit 37 north on TN-107/TN-81 for about 22 miles. Follow signs for TN-81N through Jonesborough. After passing the Marathon, keep an eye out for a sharp right turn, where you'll continue straight onto Pleasant Grove Rd. for .8 miles. Turn right onto Glendale Rd for 3.4 miles.

**RV NOTICE:** Highly advised that you come in via: I-81 - TN 93 (Exit 50) - TN-81N - Oak Hill Cir (Across from Oak Hill Baptist Church) - Oak Hill Rd - Martin Rd - Glendale Rd

**CAMPING & RV PARKING:** Permitted on the field at the event site. No hookups. Camping is available after 4 PM Friday, April 18, 2025.

**FIELD CONDITIONS:** There is some limited shade at the edges of this field. Bring water and plan to provide shade for your dogs in case the shaded areas are already taken.

**HOSPITALITY:** Morning hospitality will be available. Donations are always appreciated. Lunch will be delivered to the field (around noon), but **MUST** be ordered in advance using the one-stop shop with entries. Lunch is \$10.
