Health Committee Report

- We have \$2,927.77 as of 11-11-99 in the account. We have had one very generous donation since our last Board Meeting from Chris and Paul Danker made in memory of Ch. Sky Run's Along for the Ride.
- Barbara Yoon and Maureen Bardwell have been busy raising money through raffles and print sales at the New England Specialty and on the net. They have our utmost gratitude for their help.
- We have received a proposal for a research program that BCGNY wishes to be part of with AKC and is asking us to come on board with other clubs.
- Lou Avant, DVM has worked on a proposal for a Health Registry for our breed.
- Barbara Binder is coordinating the health clinics to be held at our 2000 National. She is working to have the following: microchips, thyroid testing, cardiac testing, CERF, and possi-

bly even a sperm collection and storage one day. She has been helping me find a speaker on osteosarcoma in the west coast area. I will be contacting Debbie Lynch at the AKC Health Foundation to see if they have a speaker on this topic.

Health seems to be on the minds of so many these days. I am so proud our club does not seem to be waiting until the breed is unhealthy overall before taking some steps to maintain our health and integrity.

I will be stepping down from the Health Committee in 2000. I have enjoyed working on this and being a part of what seems to be cutting edge ideas in our breed. I am sure whomever the Board appoints in this position will carry on in the manner that has been done in the past, making owners/breeders aware of problems facing our breed, educating them through seminars, and making contributions and hopefully becoming part of new research programs aimed at helping the breed.

Borzoi Health Registry

The BCOA Board has approved the formation of a Registry of Health Information for our beloved breed. There are actually TWO registries: the first is where you can list all of the health certifications you have acquired. We are going to try something similar to what the Siberian folks are doing with their registry on some of the standard certifications. Since the costs for the certifications seem to be an issue for some folks, what we will do is accept the signatures of Board Certified Specialists. In other words, go to the ophthalmologist once a year, fill out the CERF form, but send the form to the BCOA Registry instead. It will be documented that your dog has tested clear but you won't have to pay the CERF registration fee. Same with the other registries; all you need is to have a specialist in that particular field sign off on your dog and you are in. We cannot accept general practitioner signatures on this Registry. At least for the present, I personally will incur any expenses that may occur (these should be minimal and will mainly consist of the actual certificates you will receive following submission of appropriate information). Also, all Registries are open to any Borzoi owner—you do not have to be a member of BCOA to participate.

Certifications for heart, thyroid, hips and eyes are accepted. This Registry will offer a Certificate of Good Health which is good for 1 year and will have 3 levels of certification: Gold (submission

fied specialist, DOB, date of death is an optional field (this might be used should an old dog pass away during the year of certification and the owner wishes the public to know why further testing was not performed and the owner can elect to include a cause of death here—the

information will ONLY be included on the site if verified by a licensed veterinarian via letter/signature). Once a dog receives a CGH (of any level), he/she is in the database for good. In other words, should an owner choose NOT to renew testing, the registry will show that fact. The animals' previous certificates will be a matter of record.

The next registry we have in mind is a bit more broad; this will be a place where owners/breeders who wish to be more open about the disease problems in our breed can have their dogs listed along with ANY health problems present. This registry is where my heart is. This registry, if used properly, CAN make a difference in future Borzoi generations.

For admission to the Registry of Health Problems, a veterinarian signature and documentation of the pathologic condition as well as signatures from all owners and co-owners giving permission for publication of the information must be received. The information that we need is dog name, AKC#, sire/dam, owner(s), DOB, pathologic condition, age of onset of pathologic condition, date of death (if applicable).

We can start accepting data any time you send it in; the information can be in the form of faxes, scans attached to e-mails, or hard copies sent via snail mail. Jennifer Beach-Buda is working hard to get a website set up and eventually all of this information will be on our site, but in the meantime, anyone can call/write and I will give you what information I have. Let's get started on building the database up so Jennifer will have something to place on the site!!




