### Health Committee – Virginia Jones

## 2005 NATIONALS STATUS:

- a. We would like to try out Joe Roger's suggestion for a pizza party and seminar on Wednesday evening for the 2005 Nationals if all goes well with arranging for a speaker with a reasonable fee and an interesting and new topic. Nancy Hopkins is currently following up on one possible topic: How to plan your breeding program to improve health issues.
- b. We plan to offer eye, heart, microchip and DNA clinics. We tentatively have an eye specialist, Dr. Millichamp, for a clinic possibly on Thursday, but are still negotiating fees and day/time. His minimum dog number is 70 and we are trying to coax him down to 50 and working for about 6 hours approximately 1pm to 7pm on Thursday.
- c. We have a tentative vet, Dr. Krista Hunt, who has volunteered her services for the microchip clinic but is only available on Tuesday (after obedience) Friday and Saturday. I think we can work around her time table OK if we have a room available to use on any or all of these days.
- d. We do not have a confirmed cardiologist as of yet, but Nancy has contacted Texas A&M with this request as well as some other private contacts and is waiting for a response back regarding availability and prices.
- e. DNA clinic can be performed by myself and Nancy. No special skill is required for this one and can be offered any day during the week depending on our schedules and health clinic room availability.
- f. Ideally, for the clinic room we would like two adjoining rooms or a suite room. We need one room for waiting participants to check in and fill out paper work and the other room for the vet performing the clinic. Please try to arrange to have Nancy Hopkin's and my room as close to the clinic room as is possible. In Ohio I was so far away from the clinic room that I had to take my dogs to the clinic room with me all three days as it was impossible for me to make the distance back and forth.

# 2006 National Specialty – Barbara O'Neill

The Double Tree Hotel, Seattle - that was in the original proposal that was submitted to and approved by the Board for the 2006 National Specialty has not worked out. When the final contract was sent for signing it was not acceptable. A number of items had been changed. A big one was that the minimum room nights were increased and we were obligated to pay for any rooms that were not occupied in addition to paying a penalty for use of the ballroom. They would not negotiate. Jan Leikam quickly found another dog-friendly hotel in the Red Lion Hotel, Olympia, WA, however the last week in April was not available. The Shar-Pei National will be there. The only date that was available that did not conflict with a regional specialty was the week of May 22, 2006. The Board reviewed the date policy and found that it was not the date that the airlines restrict but the ground temperature. The Board has approved a change of hotel and date as it is only one week past our guideline date restriction and the Pacific Northwest is known to be well below the airline temperature restriction in mid-May.

Dee Jones, Billie Thibeaux, and Carol Backers (NBRF) very capably took charge of Rescue Committee activities at the Centennial Show in my absence.
