### **Treasurer's Report**

July expenses totaled approximately \$500.00 which is not included in the report. Also not included is the approx \$16,000 profit from the 2008 Specialty. We will have \$50,000 cash available to invest after the current CD matures.

Barbara O'Neill moved to combine \$15,000 cash with the matured CD and invest a total of \$27,000. Cindi Gredys second, **motion approved.** 

R Lynn Shell moved to accept the Treasurer's report, Barbara O'Neill second, **Motion approved.**

There was discussion regarding Delegate's report. Lydia asked the Board members who had not responded to Jon's request for feedback regarding the Mixed Breed issue to send him their thoughts. Motion to approve the Delegate's Report as amended made by Kelly Brunarski, second by Barbara O'Neill. 11 Ayes, 2 Nay. Voting Nay were Jon Steele and Jim Anderson. **Motion approved.**
