<u>Disaster Report – Robin Casey and Veni Harlan</u>

The Ready Borzoi Disaster Preparedness committee wants to remind owners to take precautions in winter. Here are a few tips...

Winter Safety for Your Borzoi

- Don't suddenly house an indoor Borzoi outdoors. Dogs require a month or more (as seasons change) to become accustomed to lower winter temperatures.
- Pay attention to snow removal. Avoid piling snow near fences and creating an escape route for curious Borzoi.
- Make sure all Borzoi have access to clean, fresh water. Invest in a water bucket heater if necessary.
- Brush coats frequently to prevent moisture from collecting.
- Keep the hair between your Borzoi's toes and pads clipped short, even with the bottom of the foot. When hair is left too long, snow sticks to it, forming ice balls that are uncomfortable and hard to remove. Long hair between the pads also reduces traction, making it easier for your dog to slip and hurt himself on the ice. Check paw pads for small cuts and cracks.
- Nails that are too long reduce traction and force the dog to walk on the backs of his feet, splaying his toes. The greater the space between his toes, the more snow will pack up between them.
- If you walk your dog on sidewalks that have been treated with de-icer, make sure to wash the dog's paws when you get home; these chemicals can irritate the skin and/or be toxic.
- Don't assume your Borzoi can endure all weather conditions because his ancestors came from Russia! Pay attention to the thermometer. If it dips below freezing, it's too cold for any dog—even those accustomed to being outside.

- If you keep your Borzoi outdoors during winter months, provide an elevated structure with a door to protect pets from wind and weather. The shelter should be large enough for your dog to be able to stand up and turn around, but small enough to retain her body heat and it should contain clean bedding materials such as straw or blankets.
- Use caution around bodies of water. Keep Borzoi away from rivers, ponds and lakes as they begin to freeze. Continue to use caution even when the water appears completely frozen.
- Cold weather may exacerbate certain conditions, such as arthritis. Sudden changes in the weather or drops in temperature may affect pets suffering from osteoarthritis. Consult your veterinarian.
- When traveling invest in wiper fluid rated to -20 degrees, windscreen de-icer aerosol (for emergency de-lcing), silicone spray for door rubbers, a PTFE mini-pump for door locks. Aside from standard emergency items consider including a shovel, blanket, warm hat and boots, and drinking water for you and your Borzoi.
- Don't leave pets alone in cars during cold weather months. When the engine is off, a car can act as a refrigerator, holding in the cold.

Canine Health Foundation Research

I received the status reports from CHF for two of the research grants we are supporting. They are attached with this report.

I met with Dr. Stanley from MSU regarding the Laryngeal Paralysis research study and inquired as to any borzoi samples she might like included in his study. She's very enthusiastic about including borzoi in the study and has already been collecting information/data on 11 borzoi to date. She will be contacting Erika Werne about borzoi inclusion in the study and also plans to petition the CHF for a follow up grant for DNA marker test development for the disease. She's very optimistic that using the borzoi breed for this DNA research would result in a quicker location of the gene marker due to the smaller population of the borzoi breed compared to Labradors. If at all possible, I would like to request the board to approve funds in the amount of \$1000 for the current CHF research project -01467: Characterization of Geriatric Onset Laryngeal Paralysis Polyneuropathy in Labrador Retrievers.

2011 NATIONALS HEALTH EVENTS:

All arrangements for the national's clinics and seminar are finalized with the exception of ordering the micro chip scanner from AKC. I'll handle that within the next week or so.

BORZOI HEALTH AND WELFARE FOUNDATION:

Nothing additional to provide regarding this proposal from Prudence Hlatky.

CANINE HEALTH FOUNDATION CHIC BORZOI TEST REQUIREMENTS:

I've sent a request to CHF/CHIC to update our test requirements by including DM testing as an optional test. At this time it's premature to know the prevalence of the disease in our breed in terms of carrier population versus at risk population. I'd like to wait until we have approximately 300 borzoi in the OFA test database to assess whether we should change the test to "required" instead of "optional". Copy of the request sent to Karen Mays for her corresponding records.

AKC BREEDER OF MERIT AWARD:

I've received several inquiries from our members regarding the clubs recommended health testing portion of the award. I sent a request to AKC that for borzoi, we would expect that any breeder of merit had CHIC numbers for their dogs. While this is a good idea for dogs produced from the time CHIC was instituted forward, for all of the dogs that existed prior to this inception, the breeder should only be required to provide vet reports of examinations on animals for recommended health testing. However, what health testing did BCOA actually recommend prior to this? I think that AKC had probably not thought the analysis part of this award out particularly well when they sent out the information and stipulated the health testing portion of it. They certainly did not contact any of the Health Liaisons for input, so that's really all I can speak to at this time.

I received your letter requesting the Borzoi Club of America's participation in an Advanced Hound Dog (!) Institute in Pennsylvania, August 11 through 14.

This event has been scheduled against the ADSJ's annual Institute in Indiana, Pennsylvania, just a couple of hours drive away. Borzoi will be presented at the ADSJ Institute that week, as they, and the other sighthounds have been, on odd-numbered years for a long time. I am already committed to the presentation on behalf of the Borzoi Club of America that week at ADSJ. We do not have the presenters, fanciers or

dogs to cover two institutes.

I would guess that the other sighthound JECs would have the same dilemma.

The AKC has been very supportive of ADSJ over the years, and the Institute's calendar week is the same every year. I find it amazing that a conflicting event would be planned by the Judges Department for the same time period, and in the same neighborhood, much less one that includes 10 of the same breeds. Such scheduling would be damaging to attendance for both events. The sighthound class at ADSJ is already one that doesn't fully subscribe every time.

The last Sighthound Institute held by AKC was set for late September 2001. It was cancelled in the aftermath of 9/11, and rescheduled for January 2002, well attended at that time. Since the letter from Kathy indicated that the Institute was in the planning stages, I hope a change can be made that will result in greater student and parent club participation as well as financial success in this tight-belt time.
