AKC Delegate (Barbara O'Neill)

The AKC Delegate meeting was held Tuesday, June 13, 2017. I was unable to attend.

The following amendments were voted on at the June meeting.

The proposed amendment to **Chapter 16, Section 6**, of the *Rules Applying to Dog Shows*, which would include the non-regular (eligible for Best of Breed/Variety) class entrants in the calculation of Grand Championship points. Currently, dogs that win Best of Breed, Best of Opposite Sex, and Select from a non-regular class (such as Veterans) can earn GCH points but are not included in the count for GCH. Amendment was adopted.

The following amendment to **Chapter 9**, **New Sections 3 and 5**, of the *Beagle Field Trial Rules*. **New Section 3** would allow Beagle Federations to hold one licensed derby stake per calendar year. **New Section 5** would allow a Beagle to earn up to one-third of the requirement for a Field Champion title from derby stakes. This amendment was brought forward by the Beagle Advisory Committee. Amendment was adopted.

The following amendment to **Chapter 9**, **New Sections 2 and 7**, of the *Beagle Field Trial Rules*. **New Section 2** would allow licensed clubs, associations and federations to hold FC only stakes at their regular licensed field trial or as an FC only stand-alone licensed field trial. **New Section 7** specifies the requirements for a dog to earn a Grand Field Champion title. This amendment was brought forward by the Beagle Advisory Committee. Amendment was adopted. The following amendment to **Chapter 14, Section 4, (Second Paragraph)** of the *Field Trial Rules and Standard Procedure for Retrievers,* which would give clubs the freedom to use a system of rotation if they desire. This amendment was brought forward by the Field Trial Advisory Committee. Amendment was adopted.

The following amendments were read at the June meeting and will voted on at the September meeting..

Chapter 16, Section 6, of the *Rules Applying to Dog Shows* - Championships. This amendment would include the dog awarded Select Dog or Bitch in the calculation of Grand Championship points for the award. The proposal was brought forward by the AKC Board of Directors based on a Staff recommendation.

Chapter 11, Section 8A, of the *Rules Applying to Dog Shows* - Dog Show Entries, Conditions of Dogs Affecting Eligibility, would require permanent identification for a dog that is disqualified if it is ever to be considered for reinstatement. Reinstatement would be conducted by AKC staff. Judges would not participate in the process. The name, AKC number, and the contact information for the owner of the disqualified or reinstated dog would be conveyed to the show superintendent. The amendment was brought forward by the Delegate Dog Show Rules Committee. The AKC Board of Directors unanimously disapproved the amendment.

Chapter 14, Section 22A, of the *Field Trial Rules and Standard Procedures for Pointing Breeds*, would allow for a National Gun Dog Championship for Gordon Setters, limited to walking handlers.

The next Delegate Meeting will be held Friday, December 15, 2017. An agenda has not been determined.

Personal Interest Items

- Your borzoi welfare should be of utmost concern and a priority. Should something happen to you individually (for an example an accident, illness, or death) who will take care of your dogs? Have you made provisions for them? Is the information readily accessible? For example, should a person be involved in a car accident and is unconscious, who will be responsible for your dogs (feeding, care, vetting and so forth), while being incapacitated. Should one of your dogs need to be euthanized due to medical reasons, who has the authority to do this? Please consider these issues and make appropriate arrangements for your hounds. Of utmost importance is that this information is readily available. Post it on your refrigerator, for example.
- The Holter Monitor is available on a rental basis to BCOA members/owners. This can be leased by an individual or a club for a small fee. This allows your borzoi's electrical heart function to be monitored for 24 hours. It does not replace an echocardiogram, though. Should you or your club be interested, please contact Nancy Hopkins @ celestialbz@mac.com for more details.

For Your Review

From the Annual Meeting May 19, 2017

- At the National Specialty, a motion was made and passed that the funds from the Beverly C. Taylor Trust only be paid to BR-NC, NBRF or other BCOA recognized 501C3 rescue groups who return intact all borzoi back to their breeders.
- BCOA has donated \$215,000 to rescue in 10 years with no loss in principal.
- Having Veteran Sweepstakes before Puppy Sweeps has been left to the show committee of the sponsoring region. They have the option to reverse the order as they deem appropriate.
- Sweepstake Age Limits have been returned to Puppy Sweeps: 6-9 and 9-12 months per AKC guidelines.

Topics to Ponder and to Provide Feedback

- The Judges Education brochure is in the process of being updated. Material to be included will be based on previously published BCOA brochures.
- Mentor Program criteria is being revised. Thanks to Lorrie Scott who put together an email presentation, which was sent to all of you.
- A committee has been formed to deal with a national disaster relief fund. Should you be interested in volunteering for this, please advise.
- The home visit report is being updated.
- National Specialty Rotation currently stands as:
 - 1. 2018- Region 5
 - 2. 2019- Region 1
 - 3. 2020- Region 4
 - 4. 2021- Region 6
 - 5. 2022- Region 3
