Judges' Education Brochure Update: On a motion by Prudence Hlatky, seconded by Joyce Katona, a new committee, separate from Judges' Education will create a brochure, the source of which shall be limited to materials previously published by BCOA. **Standing Rules Revision (Joy Windle):** Copies of the complete Standing Rules were provided in hopes that the Board will be better able to study and revise.

**Judge Mentor Program Qualifications (Lorrie Scott):** Update Clarification of who's to be mentored. In progress **Insurance:** On a motion by Karen Ackerman, seconded by Joy Windle, the crime policy was updated, increasing \$75,000 to \$100,000, at the cost of an additional \$22/year.

**Audit Update**: Karen Ackerman suggested a paper trail of all recordkeeping & forwarded to Nancy Katsarelas. Tabled, pending response from the previous Treasurer.

**Canine Ambassador Program** Rebecca Peters-Campbell will ask Suzanne Cecere to put together a presentation for the annual meeting.

**National Disaster Relief Fund:** It was agreed to form a five-member committee, three of whom are empowered to approve emergency funds, which will develop its own standing rules, forms, and procedures. Veni Harlan. Governors will canvas their regions for volunteers.

Home Visit Report: Joy Windle will send the draft template again.

**Re-donating Medals:** Ron Williams volunteered to invite members to re-donate their medallion caches at the annual meeting. On a motion by Prudence Hlatky, the meeting was recessed until 15 May 2017

**National Specialty Rotation:** rotation stands as it is, with 2018 Region 5, 2019 Region 1, 2020 Region 4, 2021 Region 6, and 2022 Region 3. On a motion by Jan Leikam, seconded by Karen Ackerman, the Board denied the request from Region 3 to host in 2020.

**Membership Reinstatement Application:** On a motion by Prudence Hlatky, seconded by Barbara O'Neill, the Board decided not to create a new application form specifically for reinstatement.

**High in Trial Trophy (Joyce Katona):** On a motion by Joyce Katona, seconded by Barbara O'Neill, the Board approved re-donated of the High in Trial Challenge Trophy by June Mintchell with the following wording "The Leapin' Lena Trophy donated by Todd & Toby Brandtman, retired by & generously re-donated by June Mintchell and re-named in 2017 in memory of Bonnie Nichols." Bequest from Nadine Johnson's Estate: On a motion by Barbara O'Neill, seconded by Prudence Hlatky, the Board accepted a bronze from Nadine Johnson's estate to be used as a challenge trophy. Nadine's family will provide base and nameplates. the Rising Star Challenge Trophy for Best of Opposite Sex to Best of Breed at the National Specialty.

**Report from Borzoi Finders List (Joyce Katona):** Cindi Gredys will present a draft, based on the Whippet Club of America's program at the Annual Meeting.

**MBC Specialties (Joyce Katona):** The MBC specialties have been approved by AKC; it is requested that they be added to the BCOA calendar.

**AKC Breed College (Prudence Hlatky):** A question regarding the AKC judges program was raised. Karen Mays will send her group minutes to the Board. Constitution and By-laws Potential Amendment: Amendment of the Constitution & By-Laws is a lengthy process, which cannot be undertaken lightly. Because the AKC must approve any changes, it is best if all amendments are submitted together. While the ultimate responsibility falls to the Board, members are encouraged contact their regional governors to volunteer to serve on the Amendment committee to create a draft proposal. Annual Meeting:

**Mentor Criteria Revision (Lorrie Scott):** The committee will present a draft to the members at the Annual Meeting.

**Difference between rescues:** BR-NC has applied to BCOA Breed Welfare for additional funds, the need arising from an increase in recent activity and expenses. BCOA Welfare & Rescue was set up to help BCOA members bridge the gap in times of emergency; therefore, it is not an appropriate funder for BN-RC's request. The Board suggests that BR-NC apply to NBRF for additional funds. Karen Mays also suggested that BR-NC, as 501(c) 3 official rescue, is eligible to apply to AKC Reunite for \$2000 per year.

**Sweeps age limits (Barbara O'Neill):** Barbara O'Neill, raised the question of returning puppy sweepstakes to 6-9 and 9-12 month puppies, per AKC guidelines. It was agreed to discuss at the Annual Meeting.

**Disaster Relief Fund Committee (Barbara O'Neill):** A committee will be appointed to design and administer the Fund; a plan should be ready in 12-18 months. Veni Harlan will be invited to join the committee and regional membership will be sought.

**BCOA Breed Welfare:** On a motion by Barbara O'Neill, seconded by Prudence Hlatky, BCOA Breed Rescue and Welfare's name is changed to simply BCOA Breed Welfare. This should clarify the difference between the function and purpose of the BCOA committee and that of NBRF.

**Invitation for TSE at Orlando Royal Canine show (Karen Mays):** The Board agreed to continue funding medallions for the top five placements (BB, BS, BW, WD, & WB) but not to designate it as a BCOA TSE.
