AKC Delegate (Barbara O'Neill)

The AKC Delegate meeting was held Tuesday, June 12, 2018.

The following sentence is to be added to end of Ch. 5, Sec. 2: Ribbons or rosettes used for regular and non-regular class placements for 1st through 4th must meet the requirements, except the date of the show and location of the show need not be included.

Limited Registration – from the reaction from the first proposal this will not be addressed again.

The following amendments will be voted on at the September meeting:

Chapter 5, Section 9, of the Rules Applying to Dog Shows - Ribbons, Prizes and Trophies, allows a club to offer a three-time win trophy for Reserve Best in Show. The proposal was brought forward by the AKC Board of Directors based on a Delegate Dog Show Rules Committee and Staff recommendation. The amendment will be published in two issues of the AKC Gazette and you will be asked to vote on it at the September 2018 meeting.

Chapter 11, Section 16, of the Rules Applying to Dog Shows - Dog Show Entries, Conditions of Dogs Affecting Eligibility, would address collars and leads that are considered inappropriate for use at dog shows. The amendment was brought forward by the Delegate Dog Show Rules Committee and unanimously disapproved by the AKC Board at the February 2018 Board meeting. The Dog Show Rules Committee is requesting that this amendment go forward to the Delegates for a vote, as per the AKC Bylaws.

From July Board Minutes:

Cost of Club Insurance Based on a request from the Board, Staff investigated the cost of the AKC paying the premium for AKC Clubs' general liability or accident coverage. After discussion, the Board does not recommend that the AKC pay the insurance premium for clubs. The Board agrees with the Staff's recommendation that the AKC educate clubs about the benefits of insurance. The Board would like Staff to arrange a Delegate Forum on insurance needs for clubs.

Earning One Point for Best of Winners with Competition (1+1 = 1) The Board reviewed a recommendation to amend Rules Applying to Dog Shows Chapter 16, Section 1 to award a maximum of one championship point to Best of Winners when no points are awarded to Winners in either sex, if the combined number of regular class exhibits for both sexes meets or exceeds the minimum required for one point for the sex/division where the event is held. The Board voted to approve the proposed changes. The proposal will be read at the September Delegates' meeting and voted at the December Delegates' meeting. If approved, the change becomes effective January 1, 2019.

The next Delegate Meeting will be held Tuesday, September 25, 2018. An agenda has not been determined.
