Attached are <u>Schwab account statements</u> for ending months of August & <u>September for your records and review</u>. Also attached are the current bond ladders for both Schwab accounts. Since the last quarterly report there has been activity with corporations buying back (calling) their bond debt for with the economy doing so well this far into 2019, it is smart business for them to lower their debt levels by buying back their outstanding loans and bonds.

If the current trend continue through the end of this year, BCOA-BTRC RescAcct #1 may likely finish the year with earnings in the \$35k+ range. RescAcct #2 is currently holding with earnings in the \$20k+ range as of this date. But, the BTRC doesn't wish to be too optimistic at this time as the 4th Quarter of 2018 ended being a disaster for the markets and EOY earnings.

In light of the 2018 4<sup>th</sup> quarter markets, the current BTRC investment approach for the 4<sup>th</sup> Quarter of 2019 is to not reinvest the Fall called/matured funds immediately into the bond market, but to take a more conservative approach by sitting tight with short term investments until the end of the final two months of 2019. Likely btw now and the end of the year a portion of these funds will be placed into short term certificates of deposit.

#### Health (Nancy Hopkins)

Dr. Wismer is a Diplomate of the American Board of Toxicology and the American Board of Veterinary Toxicology. She has worked in both small animal and emergency veterinary practice. She currently is Senior Director of the ASPCA Animal Poison Control Center, teaches as an adjunct instructor at the University of Illinois, is a visiting professor at St. Matthews University (Grand Cayman), and a Consultant in Toxicology at the Veterinary Information Network. ### Legislative Liaison (Lyn Snyder Hoflin)

updates and alerts sent:

- August 30, 2019 Hattiesburg, Miss alert that City Council voting to ban home based breeding, inspection of all animal owners and limiting pets.
- September 4, 2019 Swain County, North Carolina proposed ordinance would establish a county Animal Services Center and Director, and also outline regulations regarding rabies vaccinations, nuisance, dangerous dogs, licensing, and basic care of animals.

- September 5, 2019 Hamilton County, Indiana e Hamilton County Commission scheduled a
  public hearing for Monday, September 9, to obtain input on numerous proposed changes to
  the animal control code, including further regulations of hobby breeders and troublesome
  new definitions of "backyard breeder" and "puppy mill."
- September 9, 2019 Bakersfield, California -The Bakersfield City Council announced they would address both new animal ordinances and amendments to existing ordinances on Wednesday, September 11. Among these was requirement that any animal picked up twice as a stray to be spayed or neutered, regardless of the time between the impounds. The proposals will also designated three or more dogs as a kennel and subject them to fees and inspections. In addition, the proposals require licensing of any dog three months or older, which requires proof of vaccination.
- September 19, 2019 Massachusetts Judiciary Committee considering legislation which
  prohibit the outside and unattended confinement of dogs from 10pm to 6am. The proposed
  definitions would also result in a ban on outdoor kennels if they do not provide an enclosed
  shelter with 100 square feet of space per dog. Additional hearings regarding safe dog
  ownership by holding owners of dogs responsible for damage to property or any injury,
  illness, or transmission of disease to a person or another animal; permitting sporting dog
  training areas in the state; and protecting animals from convicted animal abusers by
  prohibiting ownership.
- September 25, 2019 Prince George County, Maryland holding policy hearings involving significant changes to animal laws.
- September 26, 2019 New Hampshire Governor adds new pet vendor definition to state budget. September 27, 2019 - Prince George County vote delayed. Continue contacting officials. October 3, 2019 - Robeson County, North Carolina - Board of Commissioners requesting
  - feedback on numerous proposed changes to the county's animal control laws, which were originally written in 1990.

## Distribution of Top Five Awards at National Specialty

I was recently informed that the Board decided at the August meeting that Top Five awards will no longer be available for pickup at a ringside table during National but will instead be distributed at the Annual Awards Dinner. As I was not informed about this decision until after the fact and given no further information I assume those who made the change have figured out how these awards will be given out at the banquet? Eg: Who will distribute them and how? Will all the names be read? Will they be physically handed to attendees? What is the board's plan for this? In earlier discussions of the topic during which I was included it had been decided that handing out an additional 55 awards at the banquet would be too logistically complicated and time consuming so I look forward to hearing how you all have resolved this issue as well as the logistical details of how you expect it to be handled.

#### Mailing of awards not retrieved at National

I have made these arrangements in the past so if there is someone else volunteering to be in charge of that task, as committee chair I would appreciate being brought up to speed on this decision as well.

Thus far, the only feedback I've received after the first year's problems were ironed out is that the program continues to be enjoyable and motivating for our members.
