Status of the Borzoi Arrhythmia Project

It is important to remember that we initiated the Borzoi Arrhythmia Project with several goals in mind. One goal was to develop guidelines or norms for Holter test results in Borzoi. If we are going to be able to optimally use Holter tests as a screening tool for breeding we need to know what constitutes pathological arrhythmias in our breed. We know there is a problem with Sudden Death, but we have never had any tools to help us "see" which dogs were at risk. How can we breed away from something if there is no way to find it unless an animal dies? However, no tool is useful to breeders if it causes them to remove healthy dogs from their breeding programs, in fact, such an instrument would be dangerous for the long-term health of our breed.

At this time, until we have enough data to establish norms for Borzoi, we have been using guidelines developed for large breed dogs to provide guidance to people who need to know if the results of their dog's Holter test warrants consultation with a cardiologist. These are the same guidelines used for Dobermans. Why would we need to determine the norms for a Holter report in Borzoi? Because, while the Large-Breed Guidelines use 50 Ventricular Premature Complexes (VPCs) as the cut-off between normal and abnormal, a study conducted by Dr. Meurs, Spier, Wright, and Hamlin in 2001 found that when Boxers were excluded, healthy adult dogs had a median of 2 VPCs in a 24 hour period. 2 VPC's is a long way from 50. Do normal health Borzoi have an average of 2 VPC's or is the less than 50 count more accurate? Further, in Boxers, under 100 VPCs is considered normal, 100-300 equivocal, and greater than 300 abnormal.

So what is the norm in our breed? If you Holter your Borzoi and find 45 VPCs on the report, is your dog normal or abnormal? Should you breed your dog or not? Right now, we are using the 50 VPC cutoff, but as we gain more information this guideline may be altered either up or down.

Because we do not know what is normal for Borzoi, we are not recommending that any Borzoi be removed from breeding based on Holter test results alone. Should you receive results that are concerning we recommend that one consult with a cardiologist. If participants of the Holter Rental Program are unsure whether they should consult with a cardiologist or not, Dr. Danielle Steenkamp has kindly offered to confer with the BCOA member.

Where do Borzoi fall within this very long continuum? We must find out before the Holter test can become an ideal screening tool for breeders.

So what do we have so far?

27 individuals have submitted dogs to the Borzoi Arrhythmia Project with a total of 112 separate dogs. Some of these dogs have had multiple Holter tests brining the total up to146 separate Holter submissions. Two Borzoi with Holter tests have been diagnosed with Dilated Cardiomyopathy (Documentation of several deceased dogs with DCM have been submitted to the study but no Holter results are available from these dogs).

From this subset of dogs with Holter reports how many VPCs have been found over a 24 hour period?

The highest number of ventricular ectopic beats in 24 hours has been 2535.

Ventricular ectopic beats can include single PVCs as well as pairs, triplets, and runs (these are close groupings of PVC's with pairs being two close PVC's, Triplets being a trio of PVC's close together, and runs are multiple closely timed PVCs). ALBA Medical includes triplets as a short run. Pairs, Triplets, and runs are forms of more serious arrhythmias.

Fewer Borzoi were found to have arrhythmias originating in their atria. Arrhythmias that come from the atria are often called supraventricular. This is the term used by ALBA, the company that processes our Holter tests to provide a preliminary report.

25 Borzoi had Supraventricular ectopy. These dogs had between 1 to 1690 supraventricular ectopic beats in 24 hours. One borzoi had a supraventricular pair and two borzoi had supraventricular runs.

During the time we have been sending Holter results to Dr. Meurs and Dr. Gelzer we have had a total of 4 dogs die. Two of those died of cancer (hemangiosarcoma and lymphoma). However, one of those dogs had been diagnosed with dilated cardiomyopathy prior to dying due to cancer. The dog had an echo and Holter test just a few months before death and the cardiomyopathy was stable at that time. The other two dogs died from Sudden Death (to be referred to as Dog 1 and Dog 2).

Dog 1 had 7 single PVCs at the time of the Holter test. Dog 1 was one month short of 2 years old at the time fo the Holter test.

The owner of Dog 2 had sent in a total of 3 Holter reports for the Borzoi Arrhythmia Project.

Dog 2 died at 6 years of age.

Dog 2's Holter record is important for understanding why a dog with a Holter report like Dog 1 might die of sudden death. One Holter test may not give the complete picture of the number and quality of the ectopic beats that are occurring. Had Dog 2 only had one Holter at 5 years of age, we would wonder why such a normal dog would die of an arrhythmia. But because we have two other Holter tests on Dog 2 we can see that at least at 3 and 4 years, while this Borzoi did not have many VPCs, Dog 2 not only had ventricular pairs and runs, but also supraventricular ectopics.

Because of these two sudden deaths, Dr. Muers and Dr. Gelzer have requested that we obtain Holter test results from Borzoi puppies. The reason for this is that in some breeds with deadly arrhythmias, the number of arrhythmias peak at a young age and then as the dog ages, the arrhythmias decrease or are no longer found. The questions is, do Borzoi have an age range during which the number of arrhythmias peak?

Another interesting series of Holter tests were done on Dog 3.

Dog 3 was our first puppy tested and had a perfect Holter test at 7 months. However, when tested again at a year and 8 months Dog 3 had 21 Ventricular ectopics. While still under the 50 VPC cut-off for large-breed dogs, this dog had not only a pair, but two very troublesome runs, one run had 11 beats and the rate of that run was 250 beats per minute. This dog was at risk for sudden death. Dog 3 was put on Sotalol to control the arrhythmias and as you can see, treatment has been successful.

Dog 3 adds more data to the possibility that arrhythmias in Borzoi may have an age range during which arrhythmias peak in frequency. However, this is only two dogs and may just be a coincidence. More information is needed.

At this time, we have had one intrepid person who Holtered an entire litter of Borzoi puppies. Another stalwart individual is in the process of getting Holter tests done on a different litter. The efforts of these two individuals will be invaluable. I encourage participation by anyone interested in seeing this investigation advanced.

We are gaining information, but it will take more time and dogs to really know what is happening with our dog's heart rhythms. The more Holter data we are able to collect for Dr. Meurs and Dr. Gelzer, the sooner we will have real answers.

We are all deeply indebted to each of those people who have done Holter tests on their Borzoi and submitted the results to the Borzoi Arrhythmia Project.

Borzoi Echo Project

Thanks to efforts made by Danielle Steenkamp, cardiologists at Texas A&M University Vet School are interested in evaluating Borzoi hearts. They are interested in establishing echocardiogram norms for Borzoi and possibly studying mitral valve regurgitation in our breed. At this time, the cardiologists are focused on learning about the spectrum of cardiac disease found in our breed to better decide where they would like to focus their research. While they are doing that, they will be doing echoes on as many Borzoi hearts as they can. To assist them toward this goal, these cardiologists will be providing our OFA Echo Clinics at three Nationals—the current plan is for 2021 and 2022 in addition to this year's national.

Sonya Wesselowski DVM, MS, DACVIM/Cardiology and Ashley B Saunders, DVM, MS, DACVIM/Cardiology will be providing our echo clinic at this year's National. Please thank them for their interest in our breed!

Legislative Liaison (Lyn Snyder Hoflin)

Updates sent from October through December 2019:

- October 13, 2019 Iowa Department of Agriculture and Land Stewardship (IDALS) sought public comment on proposed animal welfare regulations.
- October 26, 2019 Nationwide notice of proposal before the United States Senate that could require the USDA to publish privately identifiable breeder information.
 October 29 - The Michigan Senate Agriculture Committee taking testimony on a bill regulating rescues and foster homes operating in Michigan.
- November 2 New Cumberland (Pennsylvania) Borough Council considering a proposal that would limit the number of animals that may be kept or maintained on any property. If passed, no one in the Borough would be able to keep or maintain on a property more than four dogs or four cats over six months of age, or six animals total.
- November 13 A proposed ordinance to ban the sale of animals in any retail pet store or commercial establishment in Smithfield, Rhode Island scheduled for public hearing.
- December 5 Iowa Department of Agriculture has finalized updates to the state's animal welfare regulations.
- December 5 Nationwide An amendment to a US Senate Appropriation Bill that modeled a U.S. House proposal removing certain privacy protections for USDA licensed pet breeders failed in the Senate version of the bill. The wording concerning privacy protections remains in the House bill.
- December 6 Florida Senate Bill 522 is set to voted on in committee on Tuesday, 12/10/19. If the bill were to be approved by the committee and be voted into law by the legislature, would become a criminal offense to allow a dog to be outside and unattended when the temperature is below 32 degrees or during a severe weather advisory/warning, even if the dog is not at risk or suffers no harm and regardless if the animal has access to an outside shelter.

Meet the Breeds (Ron Williams)

The 2020 Meet the Breeds was held January 25 & 26 in New York City. It relocated after 5 years from the Pier uptown and in conjunction with Westminster to an event on its own at the Jacob Javits Center, where it was held prior to the Pier.

It came extremely close to Borzoi not having representation at the event. No one from my usual

team was able to commit this year. After several attempts to obtain new participants from the region failed, I informed the board I wasn't going to register this year. They took action and went to social media and emails started to come in from volunteers and mostly non-BCOA members. I was able to gain the required number of people and dogs to register for the event the night before the deadline.

I have to thank the Board for stepping up and getting the word out. People literally came from near and far! Aside from myself only two were BCOA members. Two volunteers drove up from Maryland, Steve and Corissa Fanning with Arlo and Addie. Two volunteers drove up from Florida, Jay and Vickie Brown with Barnaby. The others were Melissa Kucmierczyk, Susan Skwira with Gabriel, Mary McDonald and Aaron Waltz with Jamie, Ed Zobel with Sasha and Cathy Rong with Nova. I was there with Sunni. As always, the event was well-attended by many AKC breeds, Cats from The International Cat Association and thousands of onlookers asking questions, taking photos and hugging the dogs. Our booth was overrun with smiling faces waiting for their chance to get close to see borzoi and our hairy representatives did not disappoint.

The booth setup was basically the same as other years. With the Borzoi photo backdrop as the centerpiece, I included 8x10 framed photos on the table depicting different colors of coat, a litter of puppies, lure chasing, dock diving, and each participating dog. We gave out coloring books, the remaining crayons, Borzoi buttons, BCOA magnets (25 remaining) and Borzoi cards supplied by AKC. They finally used the updated "An Introduction to the Borzoi" we supplied. We once again had a listing in the Meet the Breeds AKC Family Dog program approved by the board.

As always it was a heartwarming experience greeting the public. It was also a pleasure for me meeting several of my volunteers for the first time. A special thanks goes out to them for their time and expense to attend the event. I will be mailing them a tiny monetary thank you from AKC. The Board needs to consider approving a budget for future MTBs in NYC. It's becoming too expensive to attend and we will continue to have difficulty getting volunteers. As my extreme example. I drove in 3 consecutive days, spending \$16 toll for the Lincoln Tunnel each day, parking at the same lot \$45, \$70 and \$85. AKC supplied a free lunch and a stipend of \$300 which was split up 15 times. I'll mail \$20 to each volunteer for each day. For future MTBs, I would like the Board to consider, \$25 per day for each volunteer to offset their costs.

- (c) Eight awards (those undated on the pickup list) I either hand-delivered to recipients ringside or, in June Mitchell's case at her request, gave to Carol Enz to "repurpose" for future Nationals.
- (d) 36 awards were signed out by recipients or representatives by 5/16/2019 (Only 3 NOTRA awards were earned in 2019).
- (e) One award (Versatility IV) was picked up without signing out. Phyllis Potter contacted the recipient to confirm it had been claimed.

With regard to future Award distribution -- Some BOD members who disliked the "pickup-signout" system advocated distributing awards at the Saturday Banquet, with those unable to attend making advance arrangements with BCOA president or Trophy Chair to claim awards beforehand. However, when this idea was presented to the BCOA MembersOnly list for feedback, most recipients

appeared to prefer the convenience of keeping the system as it stands -- with awards available to collect throughout the week of the National Specialty. There seemed to be general consensus, however, that it would also be appropriate to recognize award recipients at the National in some more formal way than in the past. A notice in the National Specialty Catalog listing each year's recipients could be particularly meaningful. To conclude, I'd like to thank Jane Malloy, KC Thompson, Carol Enz, Rebecca Peters-Campbell and Karen Klein for their help with the program to date. As we enter our fifth year, we have now recognized hundreds of members' achievements with the Top Five Awards program and I'm gratified to have had the opportunity to develop a way to formally honor our members' commitment to Excellence in our Breed.
