**DIRECTIONS TO LAQUEST WHIPPET HEAVEN**

**From Founders Inn: DIRECTIONS TO LaQuest Whippet Heaven**

Take Regent University Drive and exit the hotel at the light. Turn Left onto Indian River Road. Merge slight right onto I64. Continue onto exit 299B (signs for I-664/US-13/US58/US-460/Suffolk/Newport News/Richmond (12.9 mi). Keep left at fork and continue toward 1-664N(0.2mi). Continue onto 1-664N (0.5 mi). Use the right three lanes to take exit 13A-13B for US 13N/US58E/Military Highway towards US 460E/VA-191N/Suffolk (0.7mi). Keep Left at the Fork and merge onto US-13S/US-58W (0.1 mi). Exit onto US-460 W/Pruden Blvd toward Petersburg. (11.3mi). Turn Right onto E. Main Street ( (25.9 mi). Turn Left onto VA-31 N (0.4 mi). Turn Left onto State Rte 615 (Carsley Rd) (4.9 mi). LaQuest Whippet Heaven is on the left (2.7 mi).

Camping & RV parking is permitted at the event site. Camping is allowed on the field. Large RVs and Travel Trailers should park on the gravel driveway only. RVs need to notify the FTS in advance so we know how many to plan for. Please do not show up Friday evening after dark unless you are familiar with the field as there are no lights to show the entrance. Camping on the field is free, but no hookups or water are available. RVs and Campers should make a LEFT TURN coming into the field if possible. The driveway is at an angle with drainage ditches on both sides.

An additional option for RVs is located at Airfield Camp and Conference Center: <https://www.airfieldconference.com>. They have full hookups available for \$30.00/night. The site is about 20 minutes from the Dendron Fields.

**ELIGIBILITY**

All entries must be one year of age or older and individually registered with the American Kennel Club or an AKC recognized foreign registry, or have an ILP or PAL number from the AKC. Spayed and neutered Borzoi are eligible. Monorchid & cryptorchid dogs are NOT eligible. Owners may substitute a borzoi which they own for a lame or in- season borzoi. Borzoi not present at the time of roll call will be scratched. Entries will not be acknowledged by mail. Incomplete, unsigned, conditional, unpaid or late entries will not be accepted.

**TRIAL STAKES OFFERED**

**JUNIOR COURSER (JC) & QUALIFIED COURSER (QC) TESTS:** Open to all Borzoi of an eligible breed at least 12 months of age. A Borzoi running alone shall receive one qualification from a judge, and second qualification from a different judge at a separate event, stating that the Borzoi complete a six hundred (600) yard course with a minimum of four (4) turns. The Borzoi must complete the course with enthusiasm and without interruption. **Qualified Courser** Borzoi will run with another Borzoi (Testing Borzoi). This certification is required to enter a Borzoi in an Open Stake. The handler presenting the qualifying Borzoi shall be responsible for providing the Testing Borzoi for the qualifying course. Additional rules and regulations may be found on the AKC website

**OPEN:** Open only to Borzoi that hold an AKC QC certificate OR have run in the Open Stake prior to Jan. 1, 2010, OR have a Senior Courser title, OR have an ASFA or CKC field champion title (a copy of this title must be attached to the entry form if the QC requirement is to be waived). Championship points are awarded from this stake. Borzoi under disqualification from AKC, ASFA, or CKC Field Trials may NOT be entered.

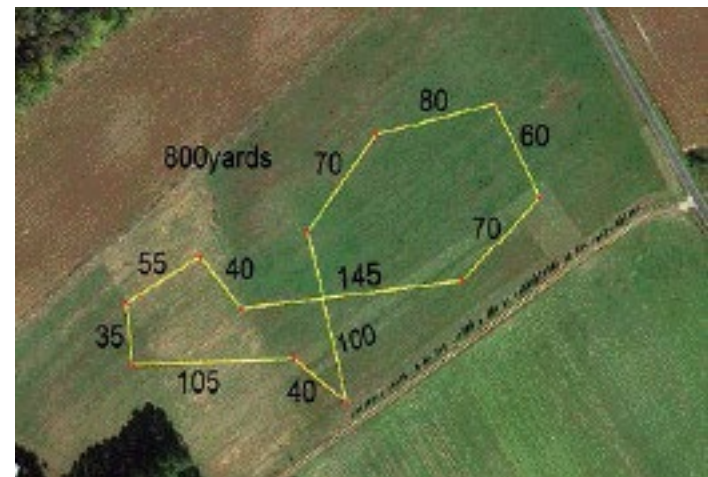
**OPEN VETERAN:** Open only to Borzoi that are eligible to enter either Open or Specials Stake, and are of Veteran age as determined by their Parent Breed Club. Championship or LCX points may be awarded from this stake. Borzoi under disqualification from AKC, ASFA, or CKC Field Trials may NOT be entered.

**SPECIALS:** Open only to Borzoi that are eligible to enter the Open Stake and have earned their AKC Field Championship title. LCX points may be awarded from this stake. Borzoi under disqualification from AKC, ASFA or CKC Field Trials may NOT be entered.

**SINGLE:** Open to all Borzoi of eligible breed, including those that are otherwise disqualified from entering the regular stakes (open, specials and veteran). Borzoi entering in the singles stake may not also enter a regular stake at the same event. No championship or LCX points are awarded from this stake.
