



Hunting with Sighthounds in Russia and America: A Comparison

Introduction

I prefer to spend the Thanksgiving holiday with my family in Ohio. However, the Thanksgiving of 2005 was destined to be different. My mom and I decided to attend The North American Coursing Association (NACA) hunts in Wyoming that took place on November 25-26, 2005. This was our first hunting experience in America, and we can now compare hunting with sight hounds in Russia and in America. My mother, Natalia Kozerskaia, was a borzoi breeder in Russia for over 25 years. I fell in love with the breed as a child and had always dreamed of owning a borzoi in the U.S. My dream came true in 2004 after sixteen years of waiting, when I got a puppy from the Majenkir kennel. When Lulu turned one and a half years old we drove to Wyoming to show her what she was bred to do.

Conditions for Hunting in Russia

In Russia sight hounds compete in hunting events from September 15 to February 15. They usually hunt rabbits and foxes. Wolf hunts, although popular in tsarist Russia, are almost nonexistent today. Hunts are usually cancelled if there is too much snow or mud in the fields. In addition, hunts are cancelled if the outside temperature is more than $+20^{\circ}$ C or if there is a profound fog. Hunting near big cities such as Moscow and St. Petersburg is limited, because there are not many rabbits and foxes left. In 2005 a hunting competition in Tambov was cancelled due to the lack of rabbits. Nowadays sight hound owners have to travel farther and farther away from big cities to allow their hounds to compete.

General Rules for Hunting with Sighthounds in Russia

Each competition is judged by three judges. It is better if they are on horseback. Nowadays, however, judges often drive in a car nearby, if conditions permit. The head judge should be qualified in open-field competition by the Department of Hunting Affairs of the Russian Federation.

In Russia the gallery is organized differently from the American gallery. The gallery usually is straight and consists of courses positioned 20 meters from each other. Hunters are allowed to release the hounds in a course only if a rabbit starts running straight ahead of them. The distance to the rabbit should be no less than 25 meters. There is no huntsmaster present, so it is up to the owners to decide when to release their dogs. When hounds are released the gallery stands still and watches the competition. Only one course can be released at once. After a course is judged, the hounds and their owners may leave the field with the permission of the judge.

Sight hounds in Russia can compete as a single, a brace or as a trio. It should be pointed out that in Russia hounds that belong to one owner can make up the same course only if they are of different sexes. In practice, however, this rule is largely ignored and hounds of the same sex belonging to the same owner often compete together. The situation is different in the U.S. because, according to NACA rule 6.9, "no owner may have his hounds competing against each other in preliminary courses."

In Russia a hound is disqualified under the following conditions:

- 1. If a hound refuses to chase her prey
- 2. If a hound does not follow the commands of her owner
- 3. If a hound chases farm animals
- 4. Owner fails to release the hound in sight of a rabbit running at 100 meters or closer

Scoring

In Russia hounds are judged based on only one course. Each course is equal. There is no preliminary and final competition. This is largely because there are not so many rabbits present in the fields. It takes hunters the entire day to be able to find a rabbit just for one course. In tsarist Russia, hunters used bloodhounds to flush rabbits and foxes out of the forest so that borzoi could catch them in the open fields.

Based on the results of just one course, the hounds may be awarded diplomas of three degrees: I, II, and III, with I being the highest. In Russia each dog in the course gets an individual score. In addition, the whole brace or trio also gets a separate score. The maximum amount of points that can be awarded is one hundred. Here is the chart showing the maximum points awarded for each category:

Agility	25
Vision (attention) and scent	15
Persistence	10
Endurance	10
Skill in the take	15
Behavior while on the leash	5
Behavior in the field	10
Treatment of the catch	10

In order to receive a third degree diploma, a hound must receive no fewer than 60 points (no fewer than 16 points should be awarded for agility and no fewer than 5 points for treatment of the catch). In order to receive a second degree diploma, a hound must score no lower than 70 points (no less than 18 for agility and 6 for treatment of the catch). In order to receive a first degree diploma, a hound must score no less than 20 for agility and 8 for treatment of the catch).

When scoring, the judges follow certain rules. For example, when judging agility, a hound is awarded the highest score if she catches the rabbit or makes a turn within a distance that is smaller than the distance she started chasing the rabbit from. According to NACA rules the judges do not give a separate mark for vision. In Russia, however, a hound gets points for vision (attention) if she is observing the fields attentively and spots a rabbit by herself without the owner showing it to her. If a hound is not carefully watching the field, up to five points can be deducted from her total score. If a hound notices a rabbit only after the owner showes it to her, up to seven points can be deducted.

The highest number of points for persistence is awarded to a dog that is most energetic and unyielding during a chase. If a hound stops chasing a rabbit or starts searching for another rabbit during her course, up to five points can be deducted from her total persistence score. If a hound stops chasing a rabbit and comes back to the owner, up to seven points can be deducted.

The highest endurance score is awarded to a dog that fearlessly chases a rabbit in any conditions (mud, ice, snow, etc.) or in any weather and does not become exhausted. If a hound after a first chase needs extensive rest and is not ready to hunt again within reasonable time allowed for rest, up to four points are deducted from her endurance score. If



a hound refuses to hunt again after her first chase, up to six points can be deducted from her endurance score.

The highest number of points for skill in the take is awarded to the hound that catches a rabbit after no more than three turns. If a rabbit is caught after four or five turns, four points are deducted from her score. If a rabbit is caught after six turns, five points are deducted from her score. If a rabbit escapes after more than six turns, seven to ten points can be deducted from the hound's score for skill in the take.

The highest score for behavior on the leash is awarded to the hound that does not act up or bother her owner while on the leash (up to three points can be deducted for bad behavior on the leash).

The highest score for behavior in the field is awarded to the hound who comes back to her owner when called, pays no attention to farm animals in the fields, and reacts to the command "no." If a hound does not follow her owner's command, up to two points can be deducted from her final score. If a hound does not listen to the command "no," up to four points can be deducted. If a hound does not return to her owner after being called, four points are deducted from her total behavior score. If a hound is aggressive towards farm animals, up to eight points are deducted from her total score. The scoring category arises from the specifics of Russian hunting conditions, because most hunts take place on farms where farm animals are present nearby. It is essential for Russian sight hounds to ignore farm animals.

Another important difference in scoring in Russia is the category "Treatment of the Catch." In America there is no similar category. The highest score in this category is awarded to a hound that is careful with the fur of the catch, brings a rabbit back to her owner, or waits for her owner near the catch. If a hound, after catching a rabbit, does not wait for her owner and starts searching for another rabbit or comes back to the owner after leaving her catch unattendend, five points are deducted from her score. If a hound tears the fur of her catch, up to six points are deducted from her score. If the latter happens a hound cannot receive a diploma during this course.

Conclusion

As seen in this article, there are many similarities and differences in open-field competition rules in the U.S. and Russia. The major similarities are the important scoring categories, such as agility, endurance, and skill in the take. The main difference is that in Russia there are additional scoring categories; such as vision (attention), persistence, behavior on the leash, behavior in the field, and treatment of the catch. Another major difference is the fact that a Russian hunting diploma can be awarded to a hound after only one course based on a single performance. This is important, because many sight hounds live in major cities and their owners do not have the luxury of participating in open-field competitions all the time. In Russia, all hunting dogs are required to show their hunting abilities before they can become breed champions. This means that all sight hounds must earn at least a third degree diploma before they may be bred. According to Galina V. Zotova, a distinguished Russian judge, the dog's hunting abilities should reflect the way she looks. In other words, the dog's confirmation should be connected with her hunting abilities. In my opinion, this is an important requirement for sight hounds and should be considered by the American Kennel Club.
